

FINAL AGREED JUDGMENT

This cause was scheduled for a contested case hearing on December 15, 2014, before the Honorable Mary M. Collier, Administrative Law Judge. In lieu of a contested case hearing, the parties hereby announce that they have reached the following agreement in this matter:

Judgment shall enter in favor of Travelers Property Casualty Company of America (“Travelers”) and against Mid-Tenn Exteriors, Inc., in the amount of fifty-three thousand dollars (\$53,000.00). Beginning October 20, 2014, Mid-Tenn Exteriors, Inc., shall pay Travelers a minimum of one thousand five hundred dollars (\$1,500.00) per week, which will be due on the Monday of each week, unless the Monday is a holiday. In the event the Monday is a holiday, the payment shall be due the following business day. Payment shall be deemed to be made when it is deposited in the mail. If Mid-Tenn Exteriors, Inc., fails to make a timely payment, it shall have three (3) days as a cure period to do so following Mid-Tenn’s receipt of written notice of Default from Travelers. For the purposes of this provision, e-mail notice shall constitute written notice. In the event Mid-Tenn Exteriors, Inc., makes timely payments and otherwise complies with the provisions of this Agreed Judgment, the Agreed Judgment shall be satisfied.


In the event, however, that Mid-Tenn Exteriors, Inc., fails to comply with making any timely payment in accordance with the provisions of this Agreed Judgment, Travelers may thereafter immediately seek and obtain execution upon Mid-Tenn Exteriors, Inc., for the Agreed Judgment Amount, less any payments made, together with interest thereon at the judgment rate of ten percent (10%) accruing from the date Mid-Tenn Exteriors, Inc., fails to make the first

timely payment, and attorney's fees, discretionary costs, court costs, and any other costs or expenses incurred related to execution. Nothing contained in this Agreed Judgment shall prevent Mid-Tenn Exteriors, Inc., from making payments in a greater amount or from satisfying the Agreed Judgment Amount prior to the payment schedule contained herein.

Mid-Tenn Exteriors, Inc., further agrees to pay all costs of the appeal incurred in the above-captioned matter. The Court is pleased that the parties have reached the foregoing agreement and will enter the same as the Court's Final Order. Together with the entry of this Agreed Judgment, Mid-Tenn Exteriors, Inc.'s appeal is also hereby dismissed with prejudice.




