You will need to provide a valid driver's license or state ID number in order to submit this application online. If you do not have a valid driver's license or state ID, you will be able to print the web prepared form and submit it by mail.

TN requirements to vote:

- You must be a U.S. Citizen
- You must be a resident of Tennessee
- You must be at least 18 years old on/or before the next election
- You must not have been convicted of a felony, or if you have, your voting rights must have been restored

An online submitted application for voter registration must be submitted at least **30 days before an election.**

or

A printed voter registration application must be postmarked or hand delivered to the proper county election commission office **at least 30 days before an election.**

Voter registration records are public records, open to inspection by any citizen of Tennessee (excluding social security and driver's license/state ID numbers).


