<u>Receive Reports and/or Requests from the Division of Health Licensure and Regulation</u> No action to be taken.

Discuss and take action as necessary regarding Legislation

Graysen Carter, Legislative Liaison, gave the 2023 legislative summary to the Board.

Public Chapter No. 55—SB680/HB895—Reeves/Hurt

This law clarifies that the Medical Assistance Act of 1968 does not require a vendor, healthcare provider, or telehealth provider group that provides healthcare services exclusively via telehealth to have a physical address or site in this state in order to be eligible to enroll as a vendor, provider, or provider group for that program. This law defines telehealth provider as two or more healthcare providers that share a common employer and provide healthcare services exclusively via telehealth. This law was effective on March 21, 2023.

Public Chapter No. 188—SB277/HB325—Johnson/Lamberth

This law extends legislation enacted in 2018 to preserve opioid prescription limitations for acute care. In addition, this law exempts individuals who had recent cancer treatment from this prescription limitation. "Recent cancer treatment" is defined as six months following the end of an active cancer treatment. This law creates an exception for informed consent where a healthcare practitioner who issued the initial prescription does not have to obtain and document informed consent, if the subsequent prescription is for the same opioid and for the same episode of treatment. Outside of this exception, informed consent must be updated periodically. This law also requires the Commissioner of the Department of Health to provide a letter, in consultation with the health-related boards, no to certain elected officials that includes information on the impact and the effects of this legislation in each even-numbered year. This law was effective on April 24, 2023. This law was a Department of Health legislative initiative.

Public Chapter No. 194—SB451/HB165—Lowe/Butler

TN Board of Veterinary Medical Examiners Meeting Minutes – August 8, 2023 Page 3 of 22 This law authorizes employees of a public accommodation to ask for certain information about a guide dog in training. A person who utilizes a guide dog is subject to the same liability for damages as a person whose pet causes damage to a place of public accommodation. Fraudulently representing that an animal is a service animal or service animal in training to an employee of a public accommodation is a Class B misdemeanor. A misrepresentation of service animal is a Class B misdemeanor and requires 100 community service hours to be served. This law is effective on July 1, 2023.

Public Chapter No. 300—SB551/HB448—Lowe/Davis

This law requires governmental entities to provide a period of public comment for public meetings but authorizes the governmental entities to place reasonable restrictions on the period for public comment. This does not apply to a meeting of a governing body, or a portion thereof, where the governing body is conducting a disciplinary hearing or a meeting for which there are no actionable items on the agenda. This takes effect July 1, 2023.

Public Chapter No. 316—SB1426/HB1004—Roberts/Darby

This law requires an appointed member of a governing body for a state entity to serve in such capacity until the member's successor is duly appointed and qualified. Under this, an appointed member of a board, commission, or other governing body for a state governmental entity may be removed by the member's appointing authority with or without cause. A vacancy created by the removal of a member must be filled by the appointing authority in the same manner as the original appointment. This law also creates an advisory council on state procurement. This law was effective on April 28, 2023.

Public Chapter No. 335—SB3195/HB472—Lundberg/Crawford

This law establishes standards for shelters that must be provided specifically to dogs under animal cruelty laws. This law takes effect on July 1, 2023.

Public Chapter No. 412—SB1398/HB1242—Reeves/Powers

This law makes it a Class A misdemeanor to knowingly possess xylazine and makes it a Class C felony to knowingly manufacture, deliver, or sell xylazine, or to knowingly possess xylazine with intent to manufacture, deliver, or sell xylazine. This law exempts veterinarians. This law is effective July 1, 2023.

Public Chapter No. 426—SB0458/HB0496—Watson/Martin

This law requires certain health related boards to either render a decision on the application or inform the applicant of the need to appear before such board within 60 days from the date the respective board receives a completed application for licensure from either an initial applicant or

TN Board of Veterinary Medical Examiners Meeting Minutes – August 8, 2023 Page 4 of 22 an applicant who is licensed in another state or territory of the United States or in the District of Columbia. This law was effective on May 11, 2023, and applies to applications submitted on or after that date.

Please note that these are high-level overviews of each public chapter. They do not include every detail or provide all bill information. Please review the text of the bill in its entirety at your own discretion. If you have any questions or need further clarity, please reach out to your attorney.

The discussion on the report is as follows: Dr. Garrett made a comment on Public Chapter #412 and spoke about the limitations of Certified Animal Control Agencies and Certified Animal Euthanasia Technicians with their limit to xylazine. He spoke about a potential federal bill to have non-humane use excluded but had not heard any updates on it at that time. There was no further discussion.

Presentation of Orders, Agreed Citations, and Other Disciplinary Items

Consent Orders

Equine Services, LLC #1215

Respondent has been at all times pertinent hereto licensed by the Board as a veterinary facility in the State of Tennessee, having been granted license/permit number 1215 on 11/02/2007, which expired on 11/30/2021.

At all times pertinent hereto Respondent facility was located in Shelbyville, Tennessee.

On or about November 30, 2021, Respondent's premises permit expired. Between November 30, 2021, and February 25, 2023, the practice of veterinary medicine occurred at Respondent's facility and/or a licensed veterinarian was practicing veterinary medicine at Respondent's facility when Respondent's permit was expired.

For the purpose of avoiding further administrative actions with respect to this cause, Respondent agrees to the following:

Respondent agrees to pay a CIVIL PENALTY in the amount of nine hundred dollars (\$900.00), which represents \$100.00 for each of nine (9) months that the facility engaged in the practice of veterinary medicine, beyond the six (6) month grace period, on an expired license/permit.

Respondent understands the ratification of this Consent Order is a formal disciplinary action and will be reported to the National Practitioner Data Bank (N.P.D.B.) and/or similar agency, as a Civil Penalty. Respondent further understands that a failure to comply with the terms of this order shall constitute grounds for disciplinary action.

Dr. McInturff made a motion to accept the Consent order, with a second from Dr. Garrett. There was no discussion.

The motion passed unanimously.

Trenton Animal Clinic #1256

TN Board of Veterinary Medical Examiners Meeting Minutes – August 8, 2023 Page 8 of 22 Respondent has been at all times pertinent hereto licensed by the Board as a veterinary facility in the State of Tennessee, having been granted license/permit number 1256 on 06/27/2008, which currently has an expiration date of 06/30/2022.

At all times pertinent hereto Respondent facility was located in Trenton, Tennessee.

On or about 6/30/22, Respondent's premises permit expired. Respondent's premises permit had not been renewed as of 5/26/23. Between 6/30/22 and 5/26/23, the practice of veterinary medicine occurred at Respondent's facility and/or a licensed veterinarian was practicing veterinary medicine when Respondent's permit was expired.

For the purpose of avoiding further administrative actions with respect to this cause, Respondent agrees to the following: Respondent agrees to pay a CIVIL PENALTY in the amount of five hundred dollars (\$500.00), which represents \$100.00 for each of five (5) months that the facility engaged in the practice of veterinary medicine, beyond the six (6) month grace period, on an expired license/permit.

Respondent understands the ratification of this Consent Order is a formal disciplinary action and will be reported to the National Practitioner Data Bank (N.P.D.B.) and/or similar agency, as a Civil Penalty. Respondent further understands that a failure to comply with the terms of this order shall constitute grounds for disciplinary action.

Dr. McInturff made a motion made to accept the Consent order, with a second from Dr. Zinkus. There was no discussion.

The motion passed unanimously.

Julio Castillo, DVM #7213

Respondent has been at all times pertinent hereto licensed by the Board as a veterinarian in the State of Tennessee, having been granted license number 7213 on 02/27/2020, which currently has an expiration date of 05/31/2025.

At all times pertinent hereto Respondent was working as a veterinarian in Smyrna, Tennessee.

On or about 3/10/22, a dog named Ozzie was taken to a veterinary clinic in Smyrna, Tennessee ("Clinic") where Respondent was employed and working as a veterinarian. Ozzie had injured her left eye the night before she was brought into the Clinic. Respondent diagnosed Ozzie as having a corneal ulcer and prescribed Optimmune ophthalmic ointment to be administered every eight hours until the ulcer was gone. On or about 3/12/22, Ozzie was brought back to the clinic because Ozzie's

TN Board of Veterinary Medical Examiners Meeting Minutes – August 8, 2023 Page 9 of 22 eye began to tum a grayish-blue color. Ozzie continued to be seen at the Clinic until 3/26/22. When Ozzie's eye condition did not improve and appeared to look worse, Ozzie was brought to s different veterinary clinic in Franklin, Tennessee and was diagnosed with a bulging corneal ulcer and she was referred to another clinic for ophthalmology services ("OS"). OS evaluated Ozzie on 03/28/2022 and performed an enucleation of the left eye on 03/29/2022.

Respondent was interviewed by a Tennessee Department of Health, Office of Investigations, investigator ("Investigator") on or about 12/13/22. In the interview, Respondent made several statements, including the following: (1) Respondent diagnosed Ozzie with a left eye corneal ulcer. (2) Respondent prescribed Ozzie Optimmune ophthalmic ointment, 0.25 inches, to be administered to Ozzie's left eye every 8 hours until the ulcer was gone, (3) Respondent confirmed that Respondent did not prescribe any other medication for Ozzie, (4) Respondent explained when asked if Optimmune ophthalmic ointment was the appropriate choice for Ozzie's diagnosis, that there could have been a better choice, and that the more appropriate medication may have been BNP (bacitracin, neomycin, and polymyxin) which is an antibiotic ointment for the eye, (5) Respondent explained that he chose Optimmune because he believed it was the best medication for a corneal ulcer when massive damage to the eye is not present, (6) Respondent explained that he believed that Terramycin ophthalmic ointment may have been a better medication to use with Ozzie, and (7) Respondent explained he was not aware of any side effects of the medication that would cause permanent damage to the eye.

For the purpose of avoiding further administrative actions with respect to this cause, Respondent agrees to the following: Respondent's license to practice as a veterinarian (License Number 7213) is hereby REPRIMANDED.

Respondent shall also complete five (5) hours of continuing education on treatment of ophthalmic diseases including corneal ulceration as approved by the Division and submit proof of completion to the Board within one (1) year from the date of ratification of this Order, in addition to the regular required continuing education for veterinarians for each calendar year.

Respondent understands the ratification of this Consent Order is a formal disciplinary action and will be reported to the National Practitioner Data Bank (N.P.D.B) and/or similar agency, as a Reprimand. Respondent further understands that a failure to comply with the terms of this order shall constitute grounds for disciplinary action.

Dr. Garrett made a motion to accept the Consent Order, with a second by Dr. Youmans. Discussion is as follows: Dr. McInturff asked if the consultants reviewed the case, and if they are licensed veterinarians. Mr. Peters stated that all orders have been reviewed by the consultants and that they are licensed veterinarians. Dr. Beaty inquired if the consent order matches the issue that was presented. Dr. Garrett stated it's also trusting the judgement of the consultants and their opinions.

Mindy Knight, LVMT #2006

Respondent has been at all times pertinent hereto licensed by the Board as a veterinary technician in the State of Tennessee, having been granted license number 2006 on 0l/15/2020, which currently has an expiration date of 02/28/2021.

At all times pertinent hereto Respondent was working as a veterinary technician in Cordova, Tennessee.

On or about February 28, 2021, Respondent's license to practice as a veterinary technician expired. Respondent sent a letter to the Board on or about 12/23/21 explaining that she had been working as a veterinary technician while her license was expired because she did not realize that her license needed to be renewed in February of 2021.

For the purpose of avoiding further administrative actions with respect to this cause,

Respondent agrees to the following:

Respondent's license to practice as a veterinary technician (License Number 2006) is hereby REPRIMANDED.

Respondent agrees to pay a CIVIL PENALTY in the amount of two hundred dollars (\$200.00), which represents \$50.00 for each of four (4) months that Respondent practiced as a veterinary technician with an expired license, beyond the six (6) month grace period.

Respondent must pay, pursuant to Tenn. Code Ann.§ 63-1-144, the actual and reasonable costs of prosecuting this case to the extent allowed by law, including all costs assessed against the Board by the State in connection with the prosecution of this matter. These costs will be established by an Assessment of Costs prepared and filed by counsel for the State. The maximum amount for the assessment of costs shall be one thousand dollars (\$1,000.00).

Respondent understands the ratification of this Consent Order is a formal disciplinary action and will be reported to the National Practitioner Data Bank (N.P.D.B.) and/or similar agency, as a Reprimand with a Civil Penalty. Respondent further understands that a failure to comply with the terms of this order shall constitute grounds for disciplinary action.

Dr. McInturff made a motion to accept the Consent order, with a second from Dr. Zinkus. There was no discussion.

Melissa Dawn Smith, LVMT, #704

Respondent has been licensed by the Board as a veterinarian medical technician in the State of Tennessee, having been granted license number 704 on September 28, 2001, with an expiration date of February 28, 2014.

Respondent was working on an expired certification from March 1, 2014, until May 14, 2021.

Respondent admitted to calling prescriptions for Tylenol #4 under a veterinarian's alleged authorization for a dog that was struck by a vehicle for approximately two years following the accident. The veterinarian did not authorize the prescription. Respondent continued to write prescriptions "for months," even after the dog passed away.

Therefore, pursuant to T.C.A. § 63-12-106 and Tenn. Comp. R. & Regs. 1730-03-.15, Respondent's agrees to the VOLUNTARY SURRENDER of Respondent's Tennessee veterinary medical technician license number 704, to be effective immediately upon ratification of this Order. Respondent understands that the VOLUNTARY SURRENDER of this license has the same effect as a revocation.

Ms. Wereszczak recuses herself. Dr. McInturff made a motion to accept the Consent Order, with a second from Dr. Zinkus. There was no discussion.

The motion passed unanimously.

Order of Compliance

Robert Barnett, DVM #6044

Amber Johnson, employed by the State of Tennessee as the Disciplinary Coordinator of the Office of General Counsel for Health-Related Boards within the Tennessee Department of Health, submitted an affidavit stating the following:

The routine business function of the Office of General Counsel to receive, investigate, and process complaints, received against health care professionals who are regulated under Title 63 of the

As the Disciplinary Coordinator of the Office of General Counsel, I am responsible for the monitoring of disciplined health care practitioners for compliance on a day-to-day basis which includes the following: collection of any fees/costs due; coordination and review of reports from peer assistance programs and/or treatment facilities/practitioners; tracking of continuing education requirements and coordinating their approval, as necessary; collecting and reviewing supervisor/preceptor reports; coordinating medical records approvals; and ensuring proper reporting to national databases.

Pursuant to the Order, entered by the Tennessee Board of Veterinary Medical Examiners on August 3rd, 2022, Robert J. Barnett, DVM, license number 6044, has been monitored by this office in accordance with the Board's Order and the standard business practices of this Office. As such, I hereby certify that the named practitioner is in compliance with the terms and conditions of said Consent Order.

The discussion is as follows: Dr. Garrett wanted to confirm that the disciplinary coordinator's office ensured that Dr. Barnett met all the requirements for an Order of Compliance. Mr. Peter's stated that the notarized affidavit states as such and he will accept that. There was no further discussion.

The motion passed unanimously.

Agreed Citation

Megan Armendariz, LVMT #1483

Ms. Armendariz was found to be in violation of TCA 63-12-120 and Tenn. R & Regs 1730-03.09, by failing to timely renew her license. Ms. Armendariz practice on a lapsed license for ten (10) months. This resulted in a civil penalty of Two Hundred dollars (\$200.00), and payment must be made within thirty (30) days.

A motion was made Dr. McInturff, to approve the Agreed Citation for Megan Armendariz #1483, as written, with a second by Dr. Garrett. Dr. Garrett asked for confirmation of the 6-month grace period prior to discipline, Ms. Boone confirmed the Board Policy.

The motion passed unanimously.

Phillip Howard, DVM #4124

TN Board of Veterinary Medical Examiners Meeting Minutes – August 8, 2023 Page 13 of 22 Dr. Howard was found to be in violation of TCA 63-12-120 and Tenn. R & Regs 1730-01-.09, by failing to timely renew his license. Dr. Howard practiced on a lapsed license for twelve (12) months. This resulted in a civil penalty Six Hundred Dollars (\$600.00), and payment must be made within thirty (30) days.

A motion was made by Dr. McInturff, to approve the Agreed Citation for Dr. Phillip Howard #4124, as written, with a second by Dr. Zinkus. There was no discussion on this motion.

The motion passed unanimously.

Audrey Knudsen, LVMT #883

Ms. Knudsen was found to be in violation of TCA 63-12-120 and Tenn. R & Regs 1730-03-.09, by failing to timely renew her license. Ms. Knudsen practiced on a lapsed license for ten (10) months. This resulted in a civil penalty Two Hundred Dollars (\$200.00), and payment must be made within thirty (30) days.

A motion was made by Dr. McInturff, to approve the Agreed Citation for Audrey Knudsen #883, as written, with a second by Dr. Zinkus. There was no discussion on this motion.

The motion passed unanimously.

Allen Bowling, DVM #1638

Dr. Bowling was found to be violation of TCA 63-12-120, by failing to properly maintain sufficient continuing education credits, and was short five (5) hours for calendar year 2020 and five (5) hours for calendar year 2021. This deficiency resulted in a civil penalty in the amount of five hundred dollars (\$500.00) and the requirement to complete all deficiency hours within 90 days.

A motion was made by Dr. McInturff, to approve the Agreed Citation for Dr. Allen Bowling #1638, as written, with a second by Dr. Zinkus. There was no discussion on this motion.

The motion passed unanimously.

Robert Fetterman, DVM #6989

Dr. Fetterman was found to be violation of TCA 63-12-120, by failing to properly maintain sufficient continuing education credits, and was short eleven (11) hours for calendar year 2021.

A motion was made by Dr. McInturff, to approve the Agreed Citation for Dr. Robert Fetterman #6989, as written, with a second by Dr. Zinkus. There was no discussion on this motion.

The motion passed unanimously.

Dr. Goodwin was found to be violation of TCA 63-12-120, by failing to properly maintain sufficient continuing education credits, and was short twenty (20) hours for calendar year 2020. This deficiency resulted in a civil penalty in the amount of one thousand dollars (\$1,000.00) and the requirement to complete all deficiency hours within 90 days.

A motion was made by Dr. McInturff, to approve the Agreed Citation for Dr. Jonathan Goodwin #6961, as written, with a second by Dr. Youmans. There was no discussion on this motion.

The motion passed unanimously.

Ashlee Kong, LVMT #2055

Ms. Kong was found to be violation of TCA 63-12-120, by failing to properly maintain sufficient continuing education credits, and was short eleven (11) hours for calendar year 2021. This deficiency resulted in a civil penalty in the amount of five hundred dollars (\$550.00) and the requirement to complete all deficiency hours within 90 days.

This deficiency resulted in a civil penalty in the amount of four hundred dollars (\$400.00) and the requirement to complete all deficiency hours within 90 days.

A motion was made by Dr. McInturff, to approve the Agreed Citation for Dr. Stocks #7049, as written, with a second by Dr. Zinkus. There was no discussion on this motion.

The motion passed unanimously.

Applicant Interviews/File Reviews/Waivers & Other Requests

Memphis Animal Services - Exemption Request

Memphis Animal Services is requesting an exemption for the need to have a Premises Permit per *TCA* 63-12-139 (*h*) "Mobile large and small animal veterinary clinics operating in more than one (1) location and examining and/or treating animals belonging to multiple clients whose animals are not permanently housed or boarded at that location shall have a premises permit for the mobile facilities that are utilized unless exempted by state or local public health officials."

Dani Rutherford, Pet Services with Memphis Animal Services (MAS), was present to speak to the Board about the request and went into detail as to why they need this exemption for the work they do around the city.

General Counsel, Mr. Peters reviewed the applicable statues for this matter. 63-12-139 designates where exemptions may come from and the first issue is authority, and where the Board's authority lies in this situation. The statute specifically names reaching out to the state or local public health officials. The statute requires a premises permit except for the exemption under (h). As the Board, the question is interpretation of who a public health official is.

TN Board of Veterinary Medical Examiners Meeting Minutes – August 8, 2023 Page 16 of 22 Dr. Beaty noted this request came to her office first and she is not a public health official in her role as State Veterinarian with the Department of Agriculture. MAS does not have a mobile facility to use for their proposed actions.

Dr. Garrett stated one of the purposes of the Board is to protect the public. Dr. Beaty noted the State epidemiologist may be the appropriate public health official. Mr. Peters noted the OGC cannot tell the board what they can or cannot do, but his role is assist the Board in protecting them in the directions they take. MAS could reach out to the legislature to pursue any changes that could provide additional guidance in statute. The question remains as to whether the Board has the authority to issue this type of exemption.

Dr. McInturff made a motion to table the request until a future meeting with a second from Dr. Garrett. Discussion on the vote is as follows: The Board's plan of action would include Mr. Peter's to do further research on this matter upon request. They need clarification on who are the public health officials as referenced in the statutes reviewed thus far.

Motion passed unanimously.

Tammy Hilkert, LVMT – CE Waiver Request

Ms. Hilkert submitted a request to make up her 2020 and 2021 continuing education hours in calendar year 2023 due to medical hardships.

There was no discussion on this matter. Dr. McInturff made a motion to approve the make-up continuing education hours in 2023 coinciding with the reinstatement application, with a second from Dr. Zinkus.

The motion passed unanimously.

Kaitlin McGuffin, DVM – CE Waiver Request
