Minutes

Dr. Garabedian asked if everyone had read the minutes from the meeting on June 21, 2022, and if so, could the committee have a motion to approve the minutes?

- Dr. Kurt Steele made the motion to accept the minutes from the June 21, 2022, committee meetings, and Dr. Montgomery McInturff seconded the motion.
- Motion carried.

Office of Finance – Alicia Grice

- Total direct expenditures for FY2022 were just over 1.6 million.
- Alicia Grice presented a breakdown to the committee the portion that each board pays related to the CSMD.
 - Medical Board approximately 34.8%
 - Nursing Board approximately 25.8%
 - Pharmacy Board approximately 19%
 - A mixture of 5-7% to the other prescribing boards

Office of Investigation (OIV) – Jaime Byerly

- Pain Management Clinics
 - Number of Pain Management Clinics currently licensed: 116 as of September 2022
 - There are two incomplete applications
 - Four pending licensure approval
 - **Overprescribing Complaints 2022 YTD**
 - Pending first review: 13
 - Currently being investigated: 24
 - Pending second review: 27
 - Pending expert review: 18
 - $\circ\;$ No open overprescribing complaints for dentists, podiatrists, optometrists, or veterinarians.

• Overprescribing Complaints 2022 YTD

- $\circ~$ One hundred thirty-three complaints have been closed.
- Closed with no violation: 23

- Closed with a letter of concern: 5

Office of General Counsel – Jae Lim

- Reported prescribing cases for May 2022 through September 2022, including:
 - One Board of Osteopathic Examiners cases
 - Five Board of Nursing cases
 - Six Board of Medical Examiners cases

Office of Informatics and Analytics – Sarah Saint

- State Unintentional Drug Overdose Reporting System- collects information on all unintentional and undetermined fatal drug overdoses in TN
 - \circ Part of the Overdose Data 2 Action Grant (funded by the CDC) Center for Disease
 - We abstract autopsies, death certificate, toxicology, report of investigation, CSMD
 - Collect over 600 variables for each case
- We have collected data for all drugs starting in 2019
- State Unintentional Drug Overdose Reporting System (SUDORS) is a part of CDC National Violent Death Reporting System (NVDRS)
- SUDORS data is collected in 6-month periods from January-June and July-December, and submitted every 6 months
- We just submitted data from July-December 2021 this past August 12th2022
- Currently we are working on data from January-June 2022, and we will submit it in February 2023
- Reasons why data is so delayed
- Overview of the Numbers



- From January 2019-December 2020, 4,976 individuals died of an unintentional or undetermined drug overdose in TN according to our SUDORS data
- Deaths increased 48% from 2019 to 2020
- Ilicit opioids and stimulants accounted for the highest proportions of death-66.6% and 48.8% respectively
- Fentanyl was the substance that occurred the most frequently on toxicology reports during these two years
- Total SUDORS Overdoses in TN, 2019 2020
 - 2006 in 2019
 - 2970 in 2020
- Evidence of Substance Use Disorder History Among SUDORS Deaths in TN, 2019 2020
 - 45% in 2019, and 44% in 2020 was No
 - 55% in 2019, and 56% in 2020 was Yes
