# Program Spotlight: Sharon's Adult Day Center

In this segment, we learn more about services from ADS providers in Tennessee. The information below has been provided by Ms. Sharon Kelly, Owner of **Sharon's Adult Day Center.**

**Sharon's Adult Day Center** opened its doors in Chattanooga, TN in 1997 as one of the first for-profit adult day centers in our state. For over 25 years, Sharon Kelly, RN has been the owner and CEO of the company. Within three years, Sharon outgrew her first location and acquired a larger location in Chattanooga. Seeing a need in Bradley County, a second facility opened in Cleveland, TN in 2009. Sharon's drive came from understanding the need for caregivers to have a break and be able to keep their loved one in the home. Her grandmother suffered with Alzheimer's disease, and her mother was the primary caregiver. Sharon witnessing how stressful it was for her mother to care for her grandmother was the catalyst for starting this great service in Chattanooga - a standalone Adult Day Center with the assistance of nurses and Certified Nurse Aides to provide a service the community needed. Sharon enjoys providing this much needed service and has served as the President for the Tennessee Association of Adult Day Services.

## **Adult Day Services Standards**

## Adult Day Services Town Hall Meeting

The first statewide Adult Day Services provider meeting was held virtually on February 22, 2023. The first half of the meeting was facilitated by Deloitte and focused on updates to the provider portal related to annual reports, change reports and incident and injury reports. The second half of the meeting was facilitated by the Tennessee Department of Human Services (TDHS) with an opportunity to discuss gaps in services; collaboration and strengthening partnerships. ADS providers identified the following gaps in services: lack of community awareness of ADS services; affordability of ADS services across income levels; service availability; and care coordinators lack of knowledge about adult day centers and the services they provide. Some of the ways that we can begin to close the gap and form more effective partnerships includes making the ADS newsletter more widely available and holding community informational meetings in each region.

#### Do you need to report suspected abuse of a vulnerable or elderly adult?

Adult Protective Services staff investigate reports of abuse, neglect (including self-neglect) or financial exploitation of adults who are unable to protect themselves due to a physical or mental limitation. APS staff assess the need for protective services and provide services to reduce the identified risk to the adult.
