

TENNESSEE DEPARTMENT OF REVENUE Sales and Use Tax Customer Refund Dealer Attestation Form

Before completing this form, a customer seeking to file a claim for refund of sales or use tax with the Department must have requested a refund from the dealer on at least two separate occasions, and the dealer failed or declined to issue the refund.

Pursuant to Tenn. Code Ann. § 67-1-1802, a dealer may complete this attestation form, which allows the customer to file a claim for refund of sales or use tax directly with the Department. This form may only be used if the refund amount exceeds \$2,500.

General Information

<u>Purpose of Form</u>: This form serves as the dealer's attestation that may be obtained by a customer, pursuant to Tenn. Code Ann. § 67-1-1802, for the customer to file a claim for refund with the Department of sales or use taxes collected by the dealer and remitted to the Department. The Department may require additional documentation from the dealer and/or the customer to assist in its evaluation of the claimed refund.

<u>Where to file:</u> The completed form is to be filed by the customer. Please attach this completed form and attachments to your Claim for Refund form and mail to the Tennessee Department of Revenue, 12th Floor Audit Division, 500 Deaderick Street, Nashville, TN 37242.
