

## **TITLE 1-A**

- **Title I Director salary and benefits**
- **Title I secretary/administrative assistant salary and benefits**
- **Teachers**
- **Educational assistants**
- **System-wide personnel**
- **Materials and supplies**
- **Equipment**
- **Professional development**
- **Pre-school program**
- **If allocation is more than \$ 500,000 – 1 % set aside for parent involvement**
- **If school is on high priority list – up to 20 % for school choice**
- **Supplemental services**
- **If L.E.A is in improvement another 10 % for professional development to address problem**
- **Schools in improvement status must budget 10 % of school allocation for staff development related to academic problem**
- **Cannot transfer money out of Title I/may transfer money into Title I from another Title allocation.**

## **Title II-A**

- **Class Size Reduction teachers**
- **Professional development related to AYP/Core academic subjects**
- **Incentives/bonuses**
- **Honoraria**
- **Testing costs for highly qualified status**
- **No more than 2 % of allocation for administration**
- **Can transfer up to 50 % of allocation out to another Title unless L.E.A. is in improvement – then only 30 %**

## **Title II-D**

- **Must spend at least 25 % for professional development related to technology integration into the classroom**
- **Equipment**
- **Acquiring, adapting, expanding, implementing, repairing and maintaining existing technology**
- **Application lists other uses of II-D funds**
- **May transfer up to 50 % of allocation to another Title**

### **Title III**

- **Used for ESL services**
- **Materials and equipment**
- **Translators**
- **No more than 2 % of allocation can be used for administration**
- **Scientifically based language instruction to increase English proficiency and student academic achievement**
- **High quality, scientifically based professional development to improve instruction and assessment of LEP students**
- **No transfers in or out**

## **Title IV**

- **Used for Safe and Drug Free School programs/initiatives**
- **Up to 40 % for School Resource Officers**
- **Up to 20 % for security**
- **Equipment, cameras, door hardware**
- **Educational programs**
- **System drug education coordinator**
- **No more than 2 % for administration**
- **May transfer up to 50 % of allocation to another Title**

## **Title V**

- **Library books**
- **Teacher Center**
- **Allowable personnel**
- **Professional development**
- **Application lists a number of allowable options**
- **No allocation provided for Title V in 2008-09**
- **May transfer money in from another Title program**

## **Title VI**

- **Not all systems qualify for Title VI**
- **Activities authorized under Title I-A**
- **Parent involvement activities**
- **Teacher recruitment/retention**
- **Professional development**
- **Activities authorized under Title IV**
- **Activities authorized under Title III**
- **May not transfer money in or out of this Title**
