Sample Tennessee Opt Out Petition

Motor vehicle and mobile equipment surface coating facilities that do not use coatings containing target hazardous air pollutants (HAPs) may petition the Administrator/delegated authority for exemption from 40 CFR 63 Subpart HHHHHH. A target HAP is defined in Section 63.11180 of the rule. Please note, if **any** coating contains a target HAP, the facility is subject to the rule.
