

## **NOTICE OF A PUBLIC MEETING TO MODIFY EXISTING HAZARDOUS WASTE MANAGEMENT FACILITY PERMIT**

EnergySolutions has requested that the Tennessee Department of Environment and Conservation (TDEC) Division of Solid Waste Management (DSWM) modify the existing Hazardous Waste storage permit at their Bear Creek Facility located in Roane County Tennessee. The modification request is for addition of three miscellaneous treatment units, liquids storage outside with secondary containment and addition of wastes acceptable for treatment.

The EnergySolutions Bear Creek Facility permit No.TNHW-129, EPA identification number: TND 98 215 7570, is located at 1560 Bear Creek Road, Oak Ridge, TN 37830. As per Tennessee Rule 1200-1-11-.07(9)(c)5(iii)(IV), a public meeting shall be conducted to answer questions or comments posed by the public regarding permit modifications. The meeting shall be held on Wednesday, April 13, 2011 at 7:00 p.m. eastern time (EST) at the DOE-Oversight Office, located at 761 Emory Valley Road, Oak Ridge, TN 37830.

As per Tennessee Rule 1200-1-11-.07(9)(c)5(iii)(II), a 60 day comment period beginning Tuesday, March 22, 2011 is established to give the public the opportunity to submit written comments regarding the permit modifications. The public may submit comments to: Ms. Angela Ivory, Treatment, Storage, and Disposal Section Division of Solid Waste Management, 5<sup>th</sup> Floor L&C Tower, 401 Church Street, Nashville, Tennessee 37243-1535. Comments must be received by 4:30 pm CST on Friday, May 20, 2011, to assure consideration. After considering all public comments, the DSWM Director will issue a final permit decision and a response to comments, which can be viewed at the Oak Ridge Public Library or at the TDEC Central Office in Nashville.
