NOTICE OF INTENT TO ISSUE PERMIT
FOR A SOLID WASTE DISPOSAL FACILITY

The Tennessee Department of Environment and Conservation (TDEC), Division of Solid Waste Management (DSWM), has tentatively decided to issue a solid waste disposal facility permit modification to J. M. Huber Corporation for construction, operation, closure, and post-closure care of an expansion to the existing Class II Landfill for the disposal of industrial, construction, and demolition wastes generated from J. M. Huber facility in Etowah, Tennessee operations.

The facility, identified as IDL 54-0058, is located in McMinn County, northeast of the intersection of U.S. Highway 411 and Cambria Road, Etowah, Tennessee (latitude 35°17'05" N/ longitude 84°32'20" W). No hazardous wastes, as regulated by the Tennessee Hazardous Waste Management Act (Tennessee Code Annotated, Section 68-212-101, et. seq.) and the Rules adopted pursuant to the Act, shall be accepted for disposal at this facility. The official responsible for operation of the facility is Mr. Jim Baugh, Plant Manager, J. M. Huber Corporation, P.O. Box 987, Etowah, Tennessee 37331; telephone: 423-263-2241.

Following an in-depth review of the application, DSWM has made a preliminary determination that this proposal meets the applicable requirements of Tennessee Rule Chapter 1200-1-7, Solid Waste Processing and Disposal. It is the present intent of DSWM, pending consideration of any contrary technical information received during the public comment period ending on February 10, 2011, that this permit be issued. During the public comment period provided, any interested person may submit written comments on the draft permit and may request a public hearing. A request for a public hearing shall be in writing and shall state the nature of the issues proposed to be raised in the hearing. Comments must be received by 4:30 p.m. (CST) on Thursday, February 10, 2011, to assure consideration. After considering all public comments, the DSWM Director will issue a final permit decision and a Response to Comments, which can be viewed at the Etowah Carnegie Public Library or at the TDEC Field Office in Chattanooga.
