An application will be deemed incomplete if it is not properly executed, if any questions are incompletely answered, if you fail to furnish telephone numbers where you can be reached, or if the examination fee is not filed with the application. **FAILURE TO COMPLETE YOUR APPLICATION MAY RESULT IN THE REJECTION OF YOUR APPLICATION.**

TO AVOID ERROR AND DELAY:

1. Read each part of your original application and your re-examination application **CAREFULLY** before making any entries.
2. When using additional paper to supplement answers, give information in the same manner as called for in your original application.
3. Have your application notarized. **Submit your application in DUPLICATE and retain a copy for your files.**
4. Please notify this office **IN WRITING** of any address changes, at the time of the change.
5. If you have a disability requiring special accommodations, you must complete the disability questionnaire for this examination, and include a current, supporting report from your treating physician and/or psychologist. Special accommodations will be determined only by what is requested on **this** current questionnaire.
6. **The fee for re-examination is \$200.00.** Make sure to include this fee with your completed application. Your check should be made payable to the Tennessee Board of Law Examiners.
