AN ACT to amend Tennessee Code Annotated, Title 68, Chapter 11, Part 2, relative to the taxable privilege of engaging in the business of providing nursing home care.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 68-11-216(d)(2), is amended by deleting the words "one (1) year beginning July 1, 2000" and substituting instead the words "two (2) years beginning July 1, 2001".

SECTION 2. Tennessee Code Annotated, Section 68-11-216(d)(2) is further amended by deleting in the last sentence, in both locations where it appears, the language "2000" and substituting instead the language "2001" and by deleting in the last sentence the language "2001" and substituting instead the language "2003".

SECTION 3. Tennessee Code Annotated, Section 68-11-216(d)(3), is amended by deleting in the first sentence the language "July 1, 2000" and substituting instead the language "July 1, 2001", and on July 1, 2002" and further amended by deleting in the last sentence the language "July 1, 2000" and substituting instead the language "July 1, 2001, and July 1, 2002".

SECTION 4. Tennessee Code Annotated, Section 68-11-216(d)(3), is amended by deleting the language "three thousand two hundred fifty dollars "(\$3,250)" and substituting instead the language "two thousand two hundred and twenty-five dollars "(\$2,225)".

SECTION 5. Tennessee Code Annotated, Section 68-11-216(d)(10) is amended by deleting the language "July 15, 2000" and substituting instead the language "July 15, 2001".

SECTION 6. Tennessee Code Annotated, Section 68-11-216(d)(11), is amended by deleting the last sentence in its entirety.

SECTION 7. Tennessee Code Annotated, Section 68-11-216(d)(12), is amended by deleting the language "June 30, 2001" and substituting instead the language "June 30, 2003".

SECTION 8. Tennessee Code Annotated, Section 68-11-830(d)(2)(B), is amended by deleting the language "July 15, 2001" and substituting instead the language "July 15, 2003".

SECTION 9. Tennessee Code Annotated, Section 68-11-830(d)(10) is amended by deleting the language "June 30, 2001" and substituting instead the language "July 15, 2003".

SECTION 10. If any provision of this act or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the

act which can be given effect without the invalid provision or application, and to that end the provisions of this act are declared to be severable.


SECTION 11. This act shall take effect July 1, 2001, the public welfare requiring it.
