AN ACT to amend Tennessee Code Annotated, Title 41, Chapter 21 and Title 41, Chapter 22, relative to Tennessee rehabilitative initiative in correction board (TRICOR).

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 41-22-405(d), is amended by adding the following language at the end of the subsection:

When a board member's term expires, the board may elect to have the incumbent continue to serve until a new appointment is made.

SECTION 2. Tennessee Code Annotated, Section 41-21-234, is amended by deleting subsection (a) and substituting instead the following:

(a) All inmates assigned to the custody of the department of correction shall be clothed in a uniform manufactured by TRICOR. The style and materials of such uniform shall be selected by the commissioner and shall be sufficient to distinguish such inmates from all other persons who are not assigned to the custody of the department. TRICOR shall operate programs, within correctional facilities, to manufacture such clothing.

SECTION 3. Tennessee Code Annotated, Section 41-22-405(a)(3), is amended by deleting the language "subdivision (a)(2)" and substituting instead the language "subdivision (a)(1)".

SECTION 4. Tennessee Code Annotated, Section 41-22-405, is amended by deleting subdivision (a)(2) and redesignating the remaining subdivision accordingly.

SECTION 5. Tennessee Code Annotated, Section 41-22-118, is amended by deleting the language "prison industries" wherever it appears and substituting instead the language "TRICOR programs"; and is further amended by deleting the language "industries" at the end of the last sentence of the section and substituting instead the language "programs".

SECTION 6. Tennessee Code Annotated, Section 41-22-123(b), is amended by deleting the language "the operation of prison industries" and substituting instead the language "TRICOR's operation"; and is further amended by deleting the language "fiscal officer of prison industries" and substituting instead the language "fiscal officer of TRICOR".

SECTION 7. Tennessee Code Annotated, Section 41-22-124(a), is amended by deleting the language "prison industries" and substituting instead the language "TRICOR".

SECTION 8. Tennessee Code Annotated, Section 41-22-401, is amended by deleting the language "Tennessee Prison Industry" and substituting instead the language "TRICOR".

SECTION 9. Tennessee Code Annotated, Section 41-22-402, is amended by deleting the language "'prison industry' means" and substituting instead the language "'TRICOR' means".

SECTION 10. Tennessee Code Annotated, Section 41-22-403(2), is amended by deleting the language "The prison industry program has a mission" and substituting instead the language "TRICOR has a mission".

SECTION 11. Tennessee Code Annotated, Section 41-22-403(3), is amended by deleting the language "prison industry jobs" and substituting instead the language "TRICOR jobs".

SECTION 12. Tennessee Code Annotated, Section 41-22-404, is amended by deleting the language "the prison industry program" and substituting instead the language "TRICOR programs"; and is further amended by deleting the language "prison industries" and substituting instead the language "TRICOR".

SECTION 13. Tennessee Code Annotated, Section 41-22-405(a)(3), is amended by deleting the language "prison industries" and substituting instead the language "TRICOR".

SECTION 14. Tennessee Code Annotated, Section 41-22-405(b), is amended by deleting the language "the prison industries program" and substituting instead the language "TRICOR".

SECTION 15. Tennessee Code Annotated, Section 41-22-405(c)(7), is amended by deleting the language "prison industries" and substituting instead the language "TRICOR".

SECTION 16. Tennessee Code Annotated, Section 41-22-406(a)(2), is amended by deleting the language "by prison industries of manufactured or agricultural products" and substituting instead the language "of TRICOR products".

SECTION 17. Tennessee Code Annotated, Section 41-22-406(b), is amended by deleting the language "prison industries" and substituting instead the language "TRICOR".

SECTION 18. Tennessee Code Annotated, Section 41-22-407(a), is amended by deleting the language "prison industries" and substituting instead the language "TRICOR".

SECTION 19. Tennessee Code Annotated, Section 41-22-407(c), is amended by deleting the language "the prison industry program" and substituting instead the language "TRICOR".

SECTION 20. Tennessee Code Annotated, Section 41-22-407(d), is amended by deleting the language "the prison industry program" and substituting instead the language "TRICOR"; and further amend by deleting the language "prison industries" and substituting instead the language "TRICOR".

SECTION 21. Tennessee Code Annotated, Section 41-22-408(b), is amended by deleting the language "prison industries" and substituting instead the language "TRICOR".

SECTION 22. Tennessee Code Annotated, Section 41-22-408(c), is amended by deleting the language "prison industries" and substituting instead the language "TRICOR".

SECTION 23. Tennessee Code Annotated, Section 41-22-408(d), is amended by deleting the language "prison industries" and substituting instead the language "TRICOR".

SECTION 24. Tennessee Code Annotated, Section 41-22-408(e), is amended by deleting the language "prison industries" and substituting instead the language "TRICOR".

SECTION 25. Tennessee Code Annotated, Section 41-22-408(f)(1), is amended by deleting the language "prison industries" and substituting instead the language "TRICOR's"; and is further amended by deleting the language "the prison industry program" and substituting instead the language "TRICOR".

SECTION 26. Tennessee Code Annotated, Section 41-22-408(f)(2), is amended by deleting the language "prison industries" wherever it appears and substituting instead the language "TRICOR".

SECTION 27. Tennessee Code Annotated, Section 41-22-408(f)(3), is amended by deleting the language "Tennessee prison industries" and substituting instead the language "TRICOR".

SECTION 28. Tennessee Code Annotated, Section 41-22-408(f)(3)(A), is amended by deleting the language "Tennessee prison industries" and substituting instead the language "TRICOR"; and further amended by deleting the language "prison industries" and substituting instead the language "TRICOR".

SECTION 29. Tennessee Code Annotated, Section 41-22-408(f)(3)(B), is amended by deleting the language "prison industries" and substituting instead the language "TRICOR".

SECTION 30. Tennessee Code Annotated, Section 41-22-411, is amended by deleting the language "prison industries" wherever it appears and substituting instead the language "TRICOR".

SECTION 31. This act shall take effect upon becoming a law, the public welfare requiring it.
