AN ACT to amend Tennessee Code Annotated, Sections 8-23-206, 8-36-118, 43-1-112, 43-1-602, 43-14-101, 43-14-218, 43-14-304, 43-14-305, 43-14-308, 49-50-104, 49-50-107, 49-50-108, 64-10-103, 69-3-132, relative to the name of the University of Tennessee agricultural extension service.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 8-23-206, is amended by deleting the words "agricultural extension services" in subsection (d)(5) and substituting the word "extension".

SECTION 2. Tennessee Code Annotated, Section 8-36-118, is amended by deleting the words "agricultural extension service" in subsection (a) and substituting the word "extension".

SECTION 3. Tennessee Code Annotated, Section 43-1-112, is amended by deleting the words "the agricultural extension service of the University of Tennessee Institute of Agriculture" in subsection (c) and substituting the words "the University of Tennessee extension".

SECTION 4. Tennessee Code Annotated, Section 43-1-602, is amended by deleting the current language of subsection (a)(3) in its entirety and substituting the following:

(3) Dean of the University of Tennessee extension;

SECTION 5. Tennessee Code Annotated, Section 43-14-101, is amended by deleting the word "agricultural" the first time it appears in subsection (1) and the second time it appears in subsection (6).

SECTION 6. Tennessee Code Annotated, Section 43-14-218, is amended by deleting the word "agricultural" in subsection (1).

SECTION 7. Tennessee Code Annotated, Section 43-14-304, is amended by deleting the words and punctuation "agricultural extension service, University of Tennessee", and substituting the words "the University of Tennessee extension".

SECTION 8. Tennessee Code Annotated, Section 43-14-305, is amended by deleting the word "agricultural".

SECTION 9. Tennessee Code Annotated, Section 43-14-308, is amended by deleting the words and punctuation "agricultural extension service, University of Tennessee", and substituting the words "the University of Tennessee extension".

SECTION 10. Tennessee Code Annotated, Section 49-50-104, is amended by deleting the words "the state agricultural extension service" in subsection (a) and subdivision (d)(1) and the words "the extension service" and "the agricultural extension service" in subsection (e) and substituting in all places the words "the University of Tennessee extension".

SECTION 11. Tennessee Code Annotated, Section 49-50-107, is amended by deleting the word "agricultural" in the first sentence of subsection (b)(1).

SECTION 12. Tennessee Code Annotated, Section 49-50-108, is amended by deleting the words "agricultural extension service" and substituting the word "extension".

SECTION 13. Tennessee Code Annotated, Section 64-10-103, is amended by deleting the words "agricultural extension service" in subsection (a)(3), and substituting the word "extension".

SECTION 14. Tennessee Code Annotated, Section 69-3-132, is amended by deleting the words "agricultural extension service" and substituting the word "extension".

SECTION 15. The University of Tennessee Extension Service shall spend no funds beyond those currently budgeted to accelerate the replacement of signs, letterhead, and business cards on account of the provisions of this act

SECTION 16. This act shall take effect upon becoming a law, the public welfare requiring it.
