

SENATE JOINT RESOLUTION NO. 264

A RESOLUTION to confirm the appointment of Mr. Marvell R. Mitchell to the Board of Directors of the Tennessee Education Lottery Corporation.

WHEREAS, Tennessee Code Annotated, Section 4-51-101, provides for the creation of the Tennessee Education Lottery Corporation; and

WHEREAS, Tennessee Code Annotated, Section 4-51-103, provides that the governor shall appoint seven members to the Board of Directors of the Tennessee Education Lottery Corporation; and

WHEREAS, Governor Phil Bredesen recently reappointed Mr. Marvell R. Mitchell of Memphis, Tennessee, as a member of the Board of Directors of the Tennessee Education Lottery Corporation; Mr. Mitchell will serve a five (5) year term that will expire on June 30, 2011; and

WHEREAS, Marvell Mitchell, a native Memphian, is a graduate of the University of Memphis with a bachelor's degree in marketing; and

WHEREAS, Marvell Mitchell is currently the Managing Partner of Mitchell Technology Group, LLC, a Memphis firm that installs computer networks for businesses and distributes both hardware and software. Previously, Mr. Mitchell served as District Sales Manager for Digital Equipment Corporation in Memphis from 1986 to 1995; prior to 1986, Mr. Mitchell was employed by IBM Corporation as a marketing manager; and

WHEREAS, Marvell Mitchell is on the board of the Black Business Association of Memphis and is a member of the board of the Memphis Chamber of Commerce, where he serves as Chairperson of the Minority Business Development Committee. He is also a member of the board of the Southwest Tennessee Community College Foundation and Leadership Memphis; and

WHEREAS, Tennessee Code Annotated, Section 4-51-103(f), provides that each member appointed by the governor to the Board of Directors of the Tennessee Education Lottery Corporation shall be confirmed by joint resolution of the General Assembly; now, therefore,

BE IT RESOLVED BY THE SENATE OF THE ONE HUNDRED FIFTH GENERAL ASSEMBLY OF THE STATE OF TENNESSEE, THE HOUSE OF REPRESENTATIVES CONCURRING, that we hereby confirm the appointment of Mr. Marvell R. Mitchell to the Board of Directors of the Tennessee Education Lottery Corporation for a five (5) year term to expire on June 30, 2011.
