AN ACT to amend Tennessee Code Annotated, Title 49, Chapter 1, Part 10, relative to coordinated school health and to honor the memory of Connie Hall Givens.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 49-1-1001, is amended by deleting the section in its entirety and by substituting instead the following:

§ 49-1-1001. This part shall be known and may be cited as the "Connie Hall Givens Coordinated School Health Improvement Act".

SECTION 2. Tennessee Code Annotated, Section 49-1-1003(a), is amended by deleting from the first sentence the language "a state grant program" and by substituting instead the following:

"the Connie Hall Givens coordinated school health grant program".

SECTION 3. Tennessee Code Annotated, Section 49-1-1004(a), is amended by deleting from the first sentence the language "in the grant program" and by substituting instead the following:

"in the Connie Hall Givens coordinated school health grant program".

SECTION 4. This act shall take effect upon becoming a law, the public welfare requiring it.
