SENATE JOINT RESOLUTION NO. 263

A RESOLUTION to confirm the appointment of Elizabeth Seigenthaler Courtney to the board of directors of the Tennessee education lottery corporation.

WHEREAS, Tennessee Code Annotated, Section 4-51-101, provides for the creation of the Tennessee education lottery corporation; and

WHEREAS, Tennessee Code Annotated, Section 4-51-103, provides that the governor shall appoint seven members to the board of directors of the Tennessee education lottery corporation; and

WHEREAS, Governor Phil Bredesen recently appointed Ms. Elizabeth Seigenthaler Courtney of Nashville, Tennessee, as a member of the board of directors of the Tennessee education lottery corporation; Ms. Courtney will serve a five (5) year term that will expire on June 30, 2013; and

WHEREAS, Ms. Courtney is a graduate of Boston College with a degree in English and Communications, and Ms. Courtney currently serves as Chairman and Chief Executive Officer of Seigenthaler Public Relations; and

WHEREAS, Ms. Courtney was one of six Americans selected in 2005 to participate in the Protégé Program by the Committee of 200, a global organization of prominent businesswomen; and

WHEREAS, in 2003, Ms. Courtney was one of fourteen women worldwide selected by the International Women's Forum as a Leadership Foundation Fellow to study at the John F. Kennedy School of Government at Harvard University and the Judge Institute of Management Studies at Cambridge University; and

WHEREAS, Ms. Courtney is a member of the Society of International Business Fellows and a graduate of Leadership Nashville, Class of 2001; and

WHEREAS, Tennessee Code Annotated, Section 4-51-103(f), provides that each member appointed by the governor to the board of directors of the Tennessee education lottery corporation shall be confirmed by joint resolution of the General Assembly; now, therefore,

BE IT RESOLVED BY THE SENATE OF THE ONE HUNDRED SIXTH GENERAL ASSEMBLY OF THE STATE OF TENNESSEE, THE HOUSE OF REPRESENTATIVES CONCURRING, that we hereby confirm the appointment of Ms.

Elizabeth Seigenthaler Courtney to the board of directors of the Tennessee education lottery corporation for a five (5) year term to expire on June 30, 2013.
