**SENATE JOINT RESOLUTION NO. 288**

A RESOLUTION to confirm the appointment of Julie Schuster to the Tennessee Wildlife Resources Commission.

WHEREAS, Tennessee Code Annotated, Section 70-1-201, provides for the creation of the Tennessee Wildlife Resources Commission; and

WHEREAS, Tennessee Code Annotated, Section 70-1-201, further provides that the governor shall appoint nine members to that commission; and

WHEREAS, Governor Phil Bredesen has recently appointed Ms. Julie Schuster of Pegram, Tennessee, to serve on the Tennessee Wildlife Resources Commission; and

WHEREAS, Ms. Schuster will represent District 6 in Middle Tennessee during a term that will expire on February 28, 2015; and

WHEREAS, Ms. Schuster earned an Associate Degree in Business Administration from McCook Junior College; and

WHEREAS, Ms. Schuster served as the marketing manager of Bass Pro Shops Outdoor World; and

WHEREAS, Ms. Schuster contributed to the *Outdoor Trail Magazine* Radio Program as a co-host of "Voice of the Women in the Outdoors"; and

WHEREAS, Ms. Schuster has served as a freelance outdoor writer and photographer for a wide variety of outdoor newspapers and publications and is a member of the Tennessee Outdoor Writers Association; and

WHEREAS, Ms. Schuster is involved in numerous wildlife organizations including diamond life membership in the National Wild Turkey Federation, the Rocky Mountain Elk Foundation, Ducks Unlimited, Quail Unlimited, and "Legends of the Outdoors"; and

WHEREAS, Ms. Schuster's experience and dedication with wildlife issues would be a tremendous asset to the Tennessee Wildlife Resources Commission; and

WHEREAS, Tennessee Code Annotated, Section 70-1-201(b)(1), provides that each member appointed to the Tennessee Wildlife Resources Commission by the governor shall be confirmed by the House Conservation and Environment Committee and the Senate Environment, Conservation and Tourism Committee and by joint resolution of the General Assembly prior to his or her term of office; now, therefore,

BE IT RESOLVED BY THE SENATE OF THE ONE HUNDRED SIXTH GENERAL ASSEMBLY OF THE STATE OF TENNESSEE, THE HOUSE OF REPRESENTATIVES CONCURRING, that we hereby confirm the appointment of Ms. Julie Schuster of Pegram, Tennessee, to a six (6) year term on the Tennessee Wildlife Resources Commission, such term to expire on February 28, 2015.
