WHEREAS, he is the widower of Betty Reagan, the City of Brentwood's first female commissioner, to whom he was happily married for sixty-one years, and he is the proud patriarch of five children, ten grandchildren, and three great-grandchildren; and

WHEREAS, Joe Reagan exemplifies the spirit and allegiance to family and community that are characteristic of a true Tennessean; and


