WHEREAS, Mrs. Jones was an exemplary public servant and consummate professional who worked assiduously to improve the quality of life for her fellow citizens in numerous capacities; and

WHEREAS, born January 5, 1938, to Sam May and Sallie Mae Stedman May, Mrs. Jones was a lifelong resident of Beech Bluff; and

WHEREAS, she served with acumen and alacrity in several positions during her estimable life, including as a secretary at Beech Bluff High School, as an employee at the Beech Bluff Post Office, as an accomplished homemaker, and as co-writer of a book entitled *'Bout Beech Bluff*, which she wrote with her brother, Murray May; and

WHEREAS, this remarkable woman was an active and devout member of Beech Bluff United Methodist Church, where she served as a member of Methodist Women, sang in the choir, and was a former Sunday School teacher; and

WHEREAS, she enjoyed scrapbooking, snow skiing, cooking, baking, cake decorating, canning, the outdoors, being at her home at the river, and spending time with her family and friends; and

WHEREAS, Mrs. Jones was deeply devoted to her family, and she always endeavored to remain true to family values of the highest order; and

WHEREAS, she was preceded in death by her parents; two brothers, Sherley May and Murray May; and two sisters, Helen Bell and Mary Gibson; and

WHEREAS, Nina Jones is survived by her husband of fifty-four years, Alvin Jones; two sons and their spouses, Al and Betty Jones, and Brad and Paula Jones; three grandchildren, Ty Jones and his wife, Ashlie, Bradley Jones, and Phalon Jones; one great-grandchild, Barrett Jones; and several nieces and nephews; and

WHEREAS, Mrs. Jones leaves behind an indelible legacy of integrity and probity in public life, compassion and loyalty in private life, and diligence and dedication in all her chosen endeavors; and
