WHEREAS, no stranger to awards and accolades, Mrs. Martin has been recognized as Social Worker of the Year by the National Association of Social Workers West Tennessee Branch, and she is a recipient of the Beat the Odds Community Service Award; and

WHEREAS, Freda Martin is an active and devout member of St. Augustine Catholic Church, which she serves as chairperson of the Parish Pastoral Council; and

WHEREAS, she is also deeply devoted to her family and has always endeavored to remain true to family values of the highest order; and


