### HOUSE JOINT RESOLUTION NO. 639

A RESOLUTION to honor Donald H. Alexander, MPH of the Tennessee Medical Association, for his meritorious service to the State of Tennessee.

WHEREAS, it is appropriate that the members of this legislative body should honor those resolute public servants of Tennessee who, in their years of work, have performed with uncommon devotion and enthusiasm; and

WHEREAS, Donald H. Alexander of Nashville is one such estimable person who served with distinction for thirty-nine years with the Tennessee Medical Association (TMA), and is due to retire in 2013 after serving the organization and Tennessee physicians in a number of management positions, including, ultimately, that of chief executive officer; and

WHEREAS, a native of Nashville, Don Alexander graduated from David Lipscomb University with a Bachelor of Science degree in Health and Physical Education before earning a master's degree in Public Health from the University of Tennessee at Knoxville; and

WHEREAS, Don Alexander joined the TMA in 1973, since which time he has seen nearly four decades of transformation in Tennessee's health care and medical communities and has helped shepherd the state's doctors through some of the most challenging times in their profession; and

WHEREAS, Don Alexander was the principal TMA staff member responsible for the creation of the nation's earliest Impaired Physician Program, now the Tennessee Medical Foundation's Physician Health Program, a program widely recognized and used as a model by other states; and

WHEREAS, Don Alexander also founded the first loan program in the country to assist recovering impaired physicians; and

WHEREAS, as chief executive officer of the TMA, Don Alexander led efforts to bring real medical liability reform to Tennessee, that has already aided Tennessee doctors by reducing the number of medical liability lawsuits filed, resulting in lower liability insurance premiums. These results encourage physicians to stay in our state, take on more high-risk cases, and accept more patients, thereby improving access to healthcare in our state; and

WHEREAS, Don Alexander is also involved in improving health care and the medical profession at the national level with his active involvement in the American Medical Association (AMA), serving on the Advocacy Resource Center (ARC) Executive Committee since its inception, attending national meetings and advocacy events; and

WHEREAS, Don Alexander is committed to serving physicians and patients by personally advocating for good medicine through his relationships with Tennessee's leading state and national elected representatives and policymakers; and

WHEREAS, his exemplary commitment and accomplishments on behalf of physicians and patients have earned him national recognition, in the form of a Medical Executive Lifetime Achievement Award awarded by the AMA for his significant contributions to the medical profession over the past thirty-nine years; and

WHEREAS, devoted to his family, Mr. Alexander enjoys the love and support of his wife, Joan; their children, Donald (Buddy) Alexander Jr., Casey Alexander, Lori Sephton, and Cindy Johnson; and their grandchildren, Annie Alexander, Jake Sephton, Adam Johnson, Harrison Alexander, Jennifer Johnson, Kate Alexander, Kelly Sephton, Allie Alexander, Reed Alexander, and Mason Alexander; and




