A RESOLUTION to honor and congratulate head coach Joe Sims and the Clay County High School Lady Bulldogs basketball team on winning the 2011-2012 TSSAA Division 1-A State Championship.

WHEREAS, this General Assembly is pleased to specially honor and commend those successful high school athletic teams that, through their magnificent exploits, bring honor to Tennessee and serve as exceptional ambassadors of this State; and

WHEREAS, the Clay County High School Lady Bulldogs basketball team is one such estimable team. The Lady Bulldogs recently won the 2011-2012 TSSAA Division 1-A Basketball State Tournament Championship, posting an outstanding record of twenty-seven wins and nine losses during the season; and

WHEREAS, after advancing to the state tournament championship game at the Murphy Center on the campus of Middle Tennessee State University, Clay County High School captured the Division 1-A State Girls' Basketball Championship for the first time in school history with a resounding 60-39 triumph over the team from Jackson County High School; and

WHEREAS, senior guard Mackenzie Hamilton also scored twenty points; Casey Cooper posted eleven points and ten rebounds, her second double-double of the state tournament; and Allie Brown added ten points, greatly contributing to the Lady Bulldogs' state championship victory; and


