A RESOLUTION to honor and congratulate the members of the Breath of Life Christian Center on the occasion of the church's Thirtieth Anniversary.

WHEREAS, no stranger to honors and accolades, the BOLCC was recognized by Mayor A.C. Wharton for its generous financial assistance for the victims of Hurricane Katrina; and

WHEREAS, a powerful tool in the service of the Kingdom of God, the BOLCC is one of the great religious institutions and catalysts for positive spiritual change in our State and Nation; and

WHEREAS, the BOLCC has stood on the rock-solid foundation of Christian belief, service, and love for three decades, serving as a bastion of faith and outreach to the people of Memphis, the surrounding area, and the world; now, therefore,
