WHEREAS, Daniel's noteworthy achievement is a tremendous source of pride for his parents, Ron and Lou Ann Keylon, his school, and his community; and


WHEREAS, Daniel's dedication to excellence is clearly deserving of the respect, admiration, and commendation of this legislative body; now, therefore,
