WHEREAS, through his continuing education and extensive service, he gained special qualifications as a DUI instructor, Stinger Spike System instructor, aerosol chemical weapons/handheld sprays instructor, field training officer, and crash reconstructionist; and

WHEREAS, Lieutenant Cash seized every opportunity for special training, including completing courses such as "Managing Civil Actions in Threat Incidents" and "Weapons of Mass Destruction Hands-On Training" at the Center for Domestic Preparedness, the State and Local Anti-Terrorism Training Program at Bureau of Justice Assistance, and several courses in technology and computerized investigation systems; and

WHEREAS, he also attended the United States Department of Justice Terrorism Conference, the Vehicular Homicide-DWI Conference, Accident Reconstruction School, and Advanced Collision Reconstruction School; and

WHEREAS, in his retirement, he is looking forward to spending more time with his supportive wife of fifteen years, Denise Andre; their three children, Jennifer, Russ, and Heather; and their four grandchildren, Ayden, Conner, Calli, and Brennan; and

WHEREAS, Lieutenant Richard Cash exemplifies the spirit and allegiance to family and community that are characteristic of a true Tennessean; and

WHEREAS, throughout his estimable career, Lieutenant Cash has demonstrated the utmost professionalism, ability, and integrity, winning the unbridled respect and admiration of his colleagues; now, therefore,


