WHEREAS, Mr. Rodgers truly bleeds asphalt as he hails from a family of road builders and is continuing its legacy through his hard work and dedication to the industry; and

WHEREAS, his grandfather, Ed Rodgers, Sr., served as a highway commissioner in Alabama and helped establish the Alabama Road Builders Association in 1947; his father, Ed, Jr., founded Dixie Concrete Pipe Company in the early 1950s and also served as the road superintendent of Madison County; and

WHEREAS, a man with an astute business mind, Mr. Rodgers has previously served the TRBA as First Vice President, Second Vice President, and Treasurer; and

WHEREAS, a pillar of his community, he has also given of his time and many talents as a board member and president of Associated General Contractors, Middle Tennessee Branch and is currently a member of the Department of Commerce and Insurance's Blasting Advisory Council; and

WHEREAS, his many professional and personal accomplishments aside, Mr. Rodgers is thankful for the love and companionship he shares with his wife, Susan Rodgers, his children, Mary Jane Rodgers, Allen Rodgers, and Ashley Wood and her husband, Stephen, and his grandson, Jacob; and

WHEREAS, in his free time, he enjoys bass fishing, bird hunting, spending time on his farm, and cheering on the Nashville Predators; and



BE IT FURTHER RESOLVED, that an appropriate copy of this resolution be prepared for presentation with this final clause omitted from such copy.


