WHEREAS, the Club takes pride in its numerous efforts to disseminate gardening knowledge and proficiency among its members and in the community at large; and

WHEREAS, one of the major contributions of this worthy civic organization has been the restoration and maintenance of the Revolutionary Graveyard located in historic downtown Dandridge; and

WHEREAS, the Club has maintained trees, shrubs, flowers, and bedding plants each season; the Club has also placed native stone benches in the Graveyard, along with a monument and a flagpole to honor the patriots of this great State and Nation; and


