A RESOLUTION to approve annual events by 501(c)(3) organizations in accordance with the provisions of Article XI, Section 5 of the Constitution of Tennessee, and pursuant to the Tennessee Charitable Gaming Implementation Law.

WHEREAS, Article XI, Section 5 of the Constitution of Tennessee, as implemented by the provisions of the Tennessee Charitable Gaming Implementation Law, requires each annual event operated for the benefit of a 501(c)(3) organization located in this state to be authorized by a two-thirds vote of all members elected to each house of the general assembly; now, therefore,


