WHEREAS, founded as a single store on River Rock Boulevard in Murfreesboro by Jack and Sallie Peterson in 1986, Old Time Pottery has been cultivated by their careful ministrations, along with those offered by their son, Scott Peterson, into a successful, privately-held, family-owned company with twenty-nine stores throughout the Southeast and the Midwest; and


