A RESOLUTION to honor the memory of James Thomas Kelsey of Collierville.

WHEREAS, the members of this General Assembly were greatly saddened to learn of the passing of James Thomas Kelsey of Collierville; and

WHEREAS, Mr. Kelsey was an exemplary public servant and consummate professional who worked assiduously to improve the quality of life for his fellow citizens in numerous capacities; and

WHEREAS, an astute and conscientious businessman, Mr. Kelsey also lent his time and business expertise to several family businesses, such as Kelsey Chevrolet and Kelsey Brothers Store; and

WHEREAS, James Kelsey was a dedicated civic leader who distinguished himself as a public-spirited citizen of the highest order through his work with numerous organizations, including the Rotary Club; Collierville Volunteer Fire Department; Mason Lodge No. 152, F&AM; and Collierville Chamber of Commerce; and

WHEREAS, a man of deep and abiding faith, Mr. Kelsey was a lifelong member of the Collierville Methodist Church, where he selflessly served as a Methodist youth counselor and expertly taught men's Bible studies; and

WHEREAS, he was preceded in death by his son, James Kelsey, Jr., and his brothers, Hardin Franklin Kelsey, Jr., and Dr. Richard Forrest Kelsey; and

BE IT FURTHER RESOLVED, that we express our sympathy and offer our condolences to the family of Mr. Kelsey.


