WHEREAS, in addition, the chainsaws are properly maintained and are equipped with chain brakes, all employees are properly trained for the equipment they operate, and a first-aid kit is readily available on every site; and

WHEREAS, a paragon of his profession, James Madison is an active member of the Tennessee Forestry Association and has been a Master Logger since 2001; and

WHEREAS, his many accomplishments aside, Mr. Madison is fortunate to share both love and companionship with his wife, Julie, who keeps the books for the business, and his son, Jamie, who has been working with his father for many years; and

WHEREAS, he is also a proud supporter of his community, actively participating in the Log-A-Load for Kids campaign and other worthwhile charitable organizations; and

WHEREAS, James Madison is wholly committed to the noble precepts of public service that have earned Tennessee recognition as the "Volunteer State," and he should be specially recognized; now, therefore,
