### SENATE JOINT RESOLUTION NO. 321

A RESOLUTION to confirm the appointment of Jack E. Holder of Counce to the State Forestry Commission.

WHEREAS, Tennessee Code Annotated, Section 11-4-201, provides for the creation of the State Forestry Commission within the Department of Agriculture; and

WHEREAS, Tennessee Code Annotated, Section 11-4-201, further provides that the Governor shall appoint seven (7) members to such commission for terms of five (5) years; and

WHEREAS, in 2006, Mr. Jack E. Holder of Counce, Tennessee, was appointed to serve a full term (July 1, 2006 – June 30, 2011) on the State Forestry Commission as the representative of the pulp and paper industry; his appointment was confirmed by the 104th General Assembly; and

WHEREAS, during his service on the State Forestry Commission, Mr. Holder has performed his duties with irreproachable integrity and exceptional knowledge and ability; throughout his service, he has proven himself to be a tremendous asset to the commission; and

WHEREAS, Tennessee Code Annotated, Section 11-4-201, provides that members of the State Forestry Commission are eligible to serve two (2) terms, if reappointed; and

WHEREAS, Governor Bill Haslam recently appointed Jack E. Holder to serve a second term on the State Forestry Commission; Mr. Holder will once again represent Tennessee's pulp and paper industry as a commission member during a term that will commence on July 1, 2011, and expire on June 30, 2016; and

WHEREAS, Mr. Holder has vast professional experience as a mill manager with Packaging Corporation of America, and he will continue to be a tremendous asset to the State Forestry Commission; and


WHEREAS, Tennessee Code Annotated, Section 11-4-201, provides that all members appointed to the State Forestry Commission by the Governor shall be subject to confirmation by joint resolution of the General Assembly; now, therefore,

BE IT RESOLVED BY THE SENATE OF THE ONE HUNDRED SEVENTH GENERAL ASSEMBLY OF THE STATE OF TENNESSEE, THE HOUSE OF REPRESENTATIVES CONCURRING, that we hereby confirm the appointment of Jack E. Holder of Counce, Tennessee, to a five (5) year term on the State Forestry Commission, such term to commence on July 1, 2011, and to expire on June 30, 2016.
