WHEREAS, a lifelong learner and active worker, she holds a commercial driver's license, completed training to become an accredited Child Development Associate, and has sold Avon products for over forty years, in addition to her duties at Morgan County Headstart; and

WHEREAS, she is also an active and devout member of St. Paul's Lutheran Church, to which she has belonged for sixty-six years and where she has taught nursery Sunday School classes for twenty years and helped in Bible School for a number of years; and

WHEREAS, Mary Ann Duncan has enjoyed many years with her husband, B.D. 
BE IT FURTHER RESOLVED, that an appropriate copy of this resolution be prepared for presentation with this final clause omitted from such copy.
