WHEREAS, she previously served as a volunteer counselor at Birth Choice Crisis Pregnancy Center in Jackson; and

WHEREAS, one of Teresa's real loves was the Hartland Place Ministry in Jackson, which she and some friends founded, and which has developed into a "church"; and

WHEREAS, her many accomplishments aside, Mrs. Layne was also deeply devoted to her family, and she always endeavored to remain true to family values of the highest order; and

WHEREAS, she is survived by her husband, Mark M. Layne; their four children, Matthew Jordan Layne, Christopher Daniel Layne, Julia Rhea Layne, and Jenna Marie Layne; her sisters, Janiece Wright and Rose Townsend (Jon); and her brothers, Mike Holman (Penny) and Steve Holman; and

WHEREAS, Teresa Layne leaves behind an indelible legacy of integrity and probity in public life, compassion and loyalty in private life, and diligence and dedication in all her chosen endeavors; and

BE IT FURTHER RESOLVED, that we express our sympathy and offer our condolences to the family of Mrs. Layne.


