WHEREAS, Craig Brewer of Memphis serves on the Tennessee Film, Entertainment and Music Commission, and has distinguished himself as a film director, screenwriter and Academy Award-winning songwriter, producing award winners including *Hustle & Flow*, *Black Snake Moan*, and *Footloose*, and the MTV drama series "\$5 Cover" about Memphis musicians and is, therefore, the recipient of the 2012 Chairman's Award; and

WHEREAS, the Movie and Film Industry has made invaluable contributions to the community through increased employment opportunities and its promotions of the arts and entertainment, and we would like to join Carnival Memphis in recognizing this esteemed industry; now, therefore,
