## PRIVATE CHAPTER NO. 13

HOUSE BILL NO. 1386

AN ACT to amend Chapter 272 of the Acts of 1901; as amended and rewritten by Chapter 115 of the Private Acts of 2006; and any other acts amendatory thereto, relative to the charter of the Town of Petersburg.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Article IV, Section 1, of Chapter 272 of the Acts of 1901, as amended and rewritten by Chapter 115 of the Private Acts of 2006, and any other acts amendatory thereto, is amended by deleting the second paragraph, which reads as follows:

Employees who are required to live within the town limits within six (6) months of their appointment include: Recorder, Chief of Police, and Judge.

SECTION 2. This act shall have no effect unless it is approved by a two-thirds (2/3) vote of the legislative body of the Town of Petersburg. Its approval or nonapproval shall be proclaimed by the presiding officer of the legislative body and certified to the secretary of state.

SECTION 3. For the purpose of approving or rejecting the provisions of this act, it shall be effective upon becoming a law, the public welfare requiring it. For all other purposes, it shall become effective as provided in Section 2, the public welfare requiring it.
