AN ACT to amend Tennessee Code Annotated, Section 37-2-417; Title 49, Chapter 1; Title 49, Chapter 11; Title 49, Chapter 12; Title 49, Chapter 3; Title 49, Chapter 5; Title 49, Chapter 50; Title 49, Chapter 6 and Section 62-4-122, relative to career and technical education.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 37-2-417(b)(2), is amended by deleting the word "vocational" and substituting instead the words "career and technical".

SECTION 2. Tennessee Code Annotated, Section 49-1-104(a), is amended by deleting the word "vocational" and substituting instead the words "career and technical".

SECTION 3. Tennessee Code Annotated, Section 49-1-302(a)(4)(A), is amended by deleting the words "vocational and technical education" and substituting instead the words "career and technical education".

SECTION 4. Tennessee Code Annotated, Section 49-3-306(g), is amended by deleting the word "vocational" wherever it appears and substituting instead the words "career and technical".

SECTION 5. Tennessee Code Annotated, Section 49-5-416(b), is amended by deleting the words "vocational-technical" and substituting instead the words "career and technical".

SECTION 6. Tennessee Code Annotated, Section 49-6-2006(c)(1), is amended by deleting the words "vocational education trades and industries program" and substituting instead the words "career and technical education program".

SECTION 7. Tennessee Code Annotated, Section 49-11-101(b), is amended by deleting the word "vocational" wherever it appears and substituting instead the words "career and technical".

SECTION 8. Tennessee Code Annotated, Section 49-11-102, is amended by deleting the word "vocational" wherever it appears and substituting instead the words "career and technical".

SECTION 9. Tennessee Code Annotated, Section 49-11-103(a), is amended by deleting the words "supervisor of vocational agriculture" and substituting instead the words "supervisor of agriculture education" and is further amended by deleting the words "vocational education funds" and substituting instead the words "career and technical funds" and is further amended by deleting the words "vocational agriculture" wherever they otherwise appear and substituting instead the words "agriculture education".

SECTION 10. Tennessee Code Annotated, Section 49-11-103(b), is amended by deleting the words "vocational agriculture" wherever they appear and substituting instead the words "agriculture education" and is further amended by deleting the words "vocational livestock" and substituting instead the words "agriculture education livestock".

SECTION 11. Tennessee Code Annotated, Section 49-11-104, is amended by deleting the word "vocational" wherever it appears and substituting instead the words "career and technical" and is further amended by deleting the words "vocational and technical education" in subdivision (a)(1) and substituting instead the words "career and technical education" and is further amended by

deleting the word "pre-vocational" in subdivision (b)(3) and substituting instead the words "career and technical".

SECTION 12. Tennessee Code Annotated, Section 49-11-106, is amended by deleting the word "vocational" wherever it appears and substituting instead the words "career and technical".

SECTION 13. Tennessee Code Annotated, Section 49-11-108, is amended by deleting the words "vocational technical" and substituting instead the words "career and technical".

SECTION 14. Tennessee Code Annotated, Section 49-11-201(b)(2), is amended by deleting the word "vocational" and substituting instead the words "career and technical".

SECTION 15. Tennessee Code Annotated, Title 49, Chapter 11, Part 3, is amended by deleting the words "area vocational school" wherever they appear and substituting instead the words "career and technical education center" and is further amended by deleting the words "area vocational schools" wherever they appear and substituting instead the words "career and technical education centers".

SECTION 16. Tennessee Code Annotated, Section 49-12-301, is amended by deleting the words "vocational, technical, and career pathway courses" in Article V., A. and substituting instead the words "career and technical education courses".

SECTION 17. Tennessee Code Annotated, Section 49-50-501(a)(1), is amended by deleting the words "Vocational or industrial arts" and substituting instead the words "Career and technical education".

SECTION 18. Tennessee Code Annotated, Section 62-4-122(h), is amended by deleting the word "vocational" and substituting instead the words "career and technical".

SECTION 19. Tennessee Code Annotated, Section 49-11-302(a), is amended by deleting the language "vocational education" and substituting instead "career and technical education".

SECTION 20. This act shall take effect upon becoming a law, the public welfare requiring it.
