If You Are Not Currently a Foster Parent

The Department of Children's Services does not recruit adopt-only homes and about 80 percent of the children who are adopted from foster care are adopted by the families who already are, and have been, their foster parents.

Our practice is to work with individuals who train to become foster parents, and then, if a child in DCS custody becomes available for adoption, the family caring for that child is generally the first option for adoption. This helps ensure the child already has a relationship with potential adoptive parents who have helped him or her navigate change, trauma and uncertainty and have offered continuity, safety and love.
