To relieve administrative burden on nursing facilities from the COVID-19 pandemic, participation in some score components in the QuILTSS #13 - #15 review periods were optional. To compensate for this, prior period QuILTSS scores were used as proxy to help facilities to remain consistent in their quality score. Beginning QuILTSS #16, full participation in the QuILTSS program will again be required, and the "look-back" function will no longer be applicable. Therefore, facilities will have to **ACTIVELY PARTICIPATE** in the QuILTSS program to receive points. This includes the QBlue Survey process as well as submission of documentation via Formstack.
