You must be 16 years of age to take the certification exam.

When you arrive at the testing site, you will need to provide a photo ID prior to taking the exam.

Phones are not allowed during the testing session. Anyone exhibiting unethical behavior during the examination will fail the test and be ineligible to take the exam for (1) year.
