ORDER ADOPTING EXAMINATION REPORT

Pursuant to Tenn. Code Ann. §§ 56-1-401, *et seq.*, the Insurance Division of the State of Tennessee Department of Commerce and Insurance (hereinafter referred to as the "Division") has examined certain affairs of CrestPoint Health Insurance Company, f/k/a Tennessee Insurance Company, (hereinafter also referred to as the "Company"), an insurance company domiciled in the state of Tennessee. As a result of an examination conducted as of the 31st day of December, 2011, the insurance examiner filed with the Division, on the 18th day of January, 2013, a verified written report on the examination, and a copy of that report has been sent to the Company. (The Report on Examination of CrestPoint Health Insurance Company f/k/a Tennessee Insurance Company is attached hereto and marked as Exhibit A). The Company has waived all review rights it may have with respect to the examination report, pursuant to Tenn. Code Ann. § 56-1-411(d)(1). The Division received no written rebuttal to said examination report from the Company.

Pursuant to Tenn. Code Ann. § 56-1-411, said examination report regarding the affairs of CrestPoint Health Insurance Company f/k/a/ Tennessee Insurance Company filed with the Insurance Division of the State of Tennessee Department of Commerce and Insurance on the 18th day of January, 2013, is hereby **ADOPTED** as filed.

The adoption of this examination report shall not preclude the Department from imposing

sanctions against CrestPoint Health Insurance Company f/k/a Tennessee Insurance Company for potential violations of the Tennessee Insurance Law which may be revealed in the examination report, it being the intent of this Order Adopting Examination Report merely to adopt the examination report filed by the examiner-in-charge.




