October 2012 examinees: Registration for the October 2012 exams opened on June 15, 2012. You will be able to register with NCEES until **September 6, 2012** when the registration closes. Select your state licensing board from the drop-down list on the right to view instructions for getting approved to take an exam. Contact your **licensing board** if you have questions about the approval process before then.



Update from the Director of the Professional Licensing Board:

The Board is finalizing the revisions on the Rules of Professional Conduct (Chapter 0820-4). The Board will be providing a notice of the public hearing date. The Board strongly encourages input from the licensed surveyors of our state.

The board is also continuing its review of the Rules of Continuing Education (Chapter 0820-5). This chapter has not been updated or revised since 1994 when it became effective. Tennessee Surveying Exam Registration

How do I register?

You must first apply to the [Tennessee board](#) for approval to sit for the exam. Visit [the board's website](#) for the appropriate forms, instructions, and fee information. After the board has notified you of your approval, register online with NCEES to reserve your seat for the exam. You will not be required to pay additional exam fees when registering through the NCEES website.



Exam authorization

NCEES will e-mail you 2-3 weeks before the exam with a link to download and print your exam authorization notice. Read it carefully. You will be required to present this document along with a valid, government-issued photo ID upon arrival at the exam site.

Results

NCEES will email you your results of the FS and PS portions 8-10 weeks after the exam date. The board will notify you of your TS exam results by email at the same time.

Exam Dates:

- 1) October 26-27, 2012 - Deadline to have applications (new AND retakes) in to the board office: **July 15**. ABSOLUTELY NO EXCEPTIONS WILL BE MADE.
- 2) April 12-13, 2013 - Deadline to have applications (new AND retakes) in to the board office: **January 15**. ABSOLUTELY NO EXCEPTIONS WILL BE MADE.
