ORDER ADOPTING EXAMINATION REPORT


Pursuant to Tenn. Code Ann. § 56-26-204 and Tenn. Comp. R. & Regs. 0780-1-76-.11, the Insurance Division of the State of Tennessee Department of Commerce and Insurance (“Division”) has examined certain affairs of Tennessee Independent Colleges and Universities Association Benefit Consortium, Inc., a self-funded qualified multiple employer welfare arrangement (“Arrangement”) domiciled in the state of Tennessee. As a result of an examination conducted as of the 31st day of December 2011, the examiner-in-charge filed with the Division, on the 30th day of May 2013, a verified, written report on the examination, and a copy of that report has been sent to the Arrangement. (The Report on Examination of Tennessee Independent Colleges and Universities Association Benefit Consortium, Inc. is attached hereto and marked as Exhibit A.) The Division received a response regarding the report from the Company on June 6, 2013. (The written response submitted by the Arrangement is attached hereto and marked as Exhibit B.)

Pursuant to Tenn. Code Ann. § 56-26-204 and Tenn. Comp. R. & Regs. 0780-1-76-.11, said examination report regarding the affairs of Tennessee Independent Colleges and Universities Association Benefit Consortium, Inc. filed with the Insurance Division of the State of Tennessee Department of Commerce and Insurance on the 30th day of May 2013 is hereby **ADOPTED** as filed.

The adoption of this examination report shall not preclude the Department from imposing sanctions against Tennessee Independent Colleges and Universities Association Benefit Consortium, Inc. for potential violations of the Tennessee Insurance Law which may be revealed in the examination report, it being the intent of this Order Adopting Examination Report merely to adopt the examination report filed by the examiner-in-charge.




