Separate sealed bids for the location and repair of sewer service laterals in designated areas for the Hamilton County WWTA will be received by the Hamilton County Purchasing Department Director at the McDaniel Building, 455 N. Highland Park Avenue, Chattanooga, TN 37404, before 2:00 p.m. (Eastern), on Wednesday, December 9, 2015, and then at said office publicly opened and read aloud:

This project entails location, cleanout installation, and repair/replacement (where required) for approximately 300 sewer service laterals in the Lookout Mountain area. This project will be performed in conjunction and simultaneously with service lateral inspection and evaluation projects procured under separate contract. The number of laterals to be located and/or repaired in a given work area may be increased by up to 50 percent of the bid quantity at the sole discretion of the Owner during the course of the work. Should the number of laterals be increased, the Contract Time will be proportionally extended based on the actual number of laterals assigned divided by the number included in the Bid Schedule.

No bids will be received or accepted after the above specified time for the opening of Bids. Bids submitted after the designated hour will be deemed invalid and returned unopened to the bidder.

Copies of BIDDING DOCUMENTS may be obtained at the office of CTI Engineers, Inc., (address below) upon nonrefundable payment of \$100.00 for each set. There will be no cost if the bidding documents were purchased for the initial bid.

All bidders must be licensed contractors as required by the Contractor's Licensing Act of 1994 of the General Assembly of the State of Tennessee and all acts amendatory thereof for Municipal and Utility Construction (MU), Classification A: Underground Piping in accordance with Tennessee Code Annotated, Title 62, Chapter 6, and must be able to show proof of such license and classification.

The successful bidder will be required to furnish acceptable Performance and Payment bonds in the amount of one hundred percent (100%) of the contract price for each bond. The Owner reserves the right to waive any irregularity or reject any or all bids.

This project is being funded by a Clean Water State Revolving Fund loan. The loan recipient must be in compliance with all applicable Davis-Bacon Act requirements.

DISADVANTAGED BUSINESS ENTERPRISES (DBE) REQUIREMENTS

Any contract or contracts awarded by the Owner through this invitation for bids will be funded by a State Revolving Fund (SRF) loan from the State of Tennessee. State and Federal funds will be involved in this project, and, as a result, Bidders must comply with the SRF Loan Program's Disadvantaged Business Enterprises (DBE) requirements including contacting a minimum of 10 qualified DBE sub-contractors, professional service providers, vendors, and/or suppliers by certified mail to solicit bids. The apparent successful Bidder must submit to the Owner copies of the certified letters and return receipts prior to contract award. Neither the State of Tennessee nor any of its departments, agencies, or employees is or will be a party to this Invitation to Bid or any resulting contract(s) awarded by the Owner. DBE's may examine plans at the Builders Exchange of Tennessee.
