SUBJECT: Jurisdictional Coverage Reference - US DOL/OSHA and TDLWD/TOSHA.

ABSTRACT

- Purpose:** This directive provides guidance to assist TOSHA staff make determinations about jurisdictional coverage issues that occur between TOSHA and other regulatory agencies.
- Scope:** This instruction applies TOSHA-wide.
- References:** Tennessee Code Annotated (T.C.A.) Section 50-3-104 Scope of Chapter.

- Action:** Section Managers and Area Supervisors shall ensure that the objectives and concepts inherent in this directive effectively implemented.
- Background:** The Tennessee Department of Labor and Workforce Development Division of Occupational Safety and Health (TOSHA) has been delegated the enforcement responsibility for the provisions of the Tennessee Occupational Safety Act of 1972 (Act) by the Commissioner of Labor and Workforce Development. Since the Act was promulgated, there have been occasions when jurisdiction over specific establishments has been challenged. These challenges usually involve questions about which governmental agency is responsible for employee safety at the specific

site. This document provides general reference information about jurisdictional coverage at sites where jurisdiction has been questioned.

Guidelines:

- A.** TOSHA Managers and Area Supervisors will adhere to the areas of authority delineated in this directive. The TOSHA will maintain contact with the OSHA Regional Administrator in order to coordinate the MOU. Contact and coordination is also required at the Area Office level between the respective Area Supervisor and Section Managers. When there is a question about TOSHA jurisdiction, the following references should be consulted:

 - 1. The Tennessee Code Annotated (T.C.A.) Section 50-3-104,
 - 2. The TOSHA FOM, and
 - 3. This instruction.
- B.** When a jurisdictional or coordination question arises which cannot be resolved at the area office level, or guidance is required to make a decision, the Section Manager shall be contacted. In cases where the Manager cannot determine jurisdiction, contact the TOSHA Administrator.
- C.** The Compliance Managers shall ensure that field personnel are provided with a copy of this directive and understand its purpose and use.
- D.** Whenever potential violations of a site not covered by TOSHA are identified during the period of researching the site (as in a complaint or referral), the following procedure shall be followed:

 - 1. The compliance officer shall submit a referral form (OSHA-90) through the Supervisor to the Section Manager with specific information about the potential violation.
 - 2. The Manager will insure this information is communicated to OSHA.
 - 3. In order to track activity related to this MOU, the Area Supervisor shall copy the referral to the TOSHA Administrator through the Section Manager.
- E.** An evaluation of the MOU shall be made each year by the TOSHA Administrator's Office to insure that it remains current.

		this to exempt employees working directly or indirectly for the railroad,
Recreational Boat Builders	State	TOSHA will cover all applicable recreational boat building assembly line operations, except where 1915 standards apply.
Ship Building	Federal	
Tennessee National Guard Facilities	State	Federal employees at national guard facilities are covered by federal OSHA. Uniformed military personnel are not covered per executive order #12196.
Tennessee Valley Authority	Federal	Includes facilities, employees and private contractors.
U.S. Park Service	Federal	Includes facilities, employees and private contractors.

Veterans Administration Facilities And Hospitals	Federal
