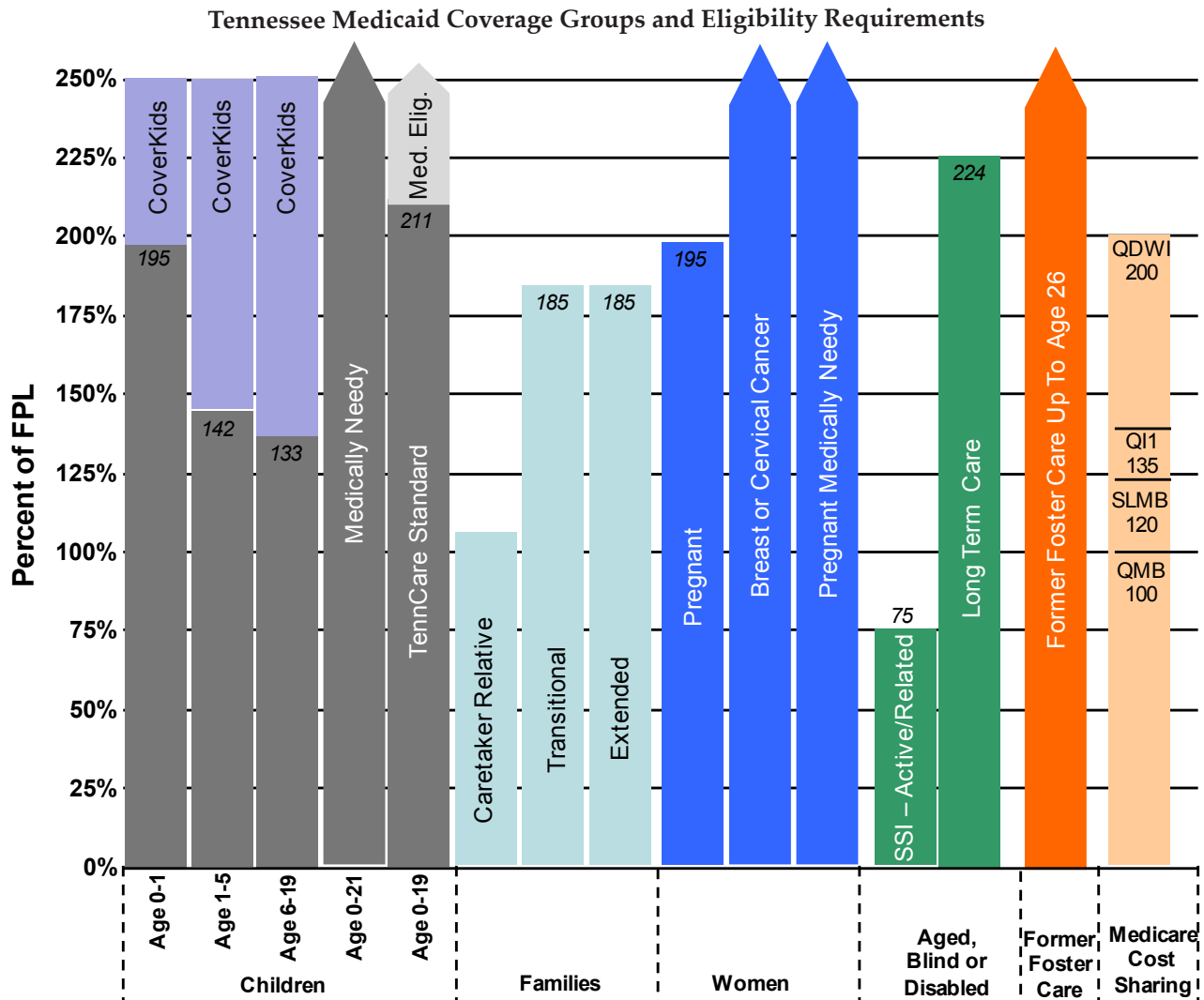


Annual and Monthly Income in Dollars

Children	Age 0 - 19	Low income children age 0 up to 1st birthday	195% of poverty - No resource test
		Low income children age 1 to 6th birthday	142% of poverty - No resource test

	Child Medically Needy	Children up to age 21. Must either have low income or have sufficient unreimbursed medical bills to spend down to requisite income limits.	Monthly spend-down levels of \$241 (1), \$258 (2), \$317 (3), \$325 (4), \$392 (5), \$408 (6), or \$467 (7) Resource: \$2,000 (1), \$3,000 (2), add \$100 per additional individual
	Standard Uninsured	Children under age 19 who do not have access to insurance. Category is only open to children who lose Medicaid eligibility and rollover into Standard.	Below 211% of poverty No resource test
	Standard Medically Eligible	Children under age 19 who do not have access to insurance and who have health conditions that make the child uninsurable. Category is only open to children who lose Medicaid eligibility and rollover into Standard.	Above 211% of poverty
	CoverKids	Available to children under age 19 and to the unborn children of women not eligible under another TennCare category.	Above TennCare income limits and below 250% of poverty No resource test
Families	Caretaker Relative	Available to parents and caretaker relatives of dependent children under age 19.	Monthly income levels of \$1,018 (1), \$1,329 (2), \$1,611 (3), \$1,867 (4), \$2,102 (5), \$2,320 (6), or \$2,524 (7) No resource test
	Transitional/Extended Medicaid	Children, pregnant women, and caretaker relatives who lose Medicaid due to an increase in income or spousal support.	185% of poverty during months 7 - 12
Women	Pregnant	Low income pregnant women. NOTE: Newborns born to Medicaid –eligible women are deemed eligible for one year.	195% of poverty No resource test
	Breast or Cervical Cancer	Women under 65 who are not eligible for any other category of Medicaid and have been diagnosed as the result of a screening at a Centers for Disease Control and Prevention (CDC) site.	250% of poverty No resource test
	Pregnant Medically Needy	Pregnant women. Must either have low income or have sufficient unreimbursed medical bills to spend down to requisite income limits. Aged, Blind & Disabled	SSI (Supplemental Security Income)	Active: Low income aged, blind, or disabled recipients of federal SSI cash payments as determined by SSA	\$735 per month (1), \$1,103(2) Resource: \$2,000 (1), \$3,000 (2)
	Long Term Care	Low income individuals who require care in a nursing facility or intermediate care facility for individuals with intellectual disabilities or who receive Home and Community-Based Services in their home.	\$2,205 per month Resource: \$2,000
	SSI-Related (Pickle/Pass Along, Disabled Adult Child, Widow/Widower)	Pickle/Pass Along: Lost SSI since 1977 due to OASDI cost-of-living increase. DAC: Lost SSI since 1987 due to receipt/increase of DAC benefits. Widow/Widower: Lost SSI due to receipt of OASDI from deceased spouse.	\$735 per month (1), \$1,103 (2) Resource: \$2,000 (1), \$3,000 (2)
Adults - Foster Care	Former Foster Care Up To Age 26	Individuals under age 26 who aged out of foster care in Tennessee and who received TennCare Medicaid at that time.	No income or resource test
Medicare Cost Sharing	QMB	Qualified Medicare Beneficiary TennCare pays Medicare premiums, deductibles and co-insurance for those eligible for Medicare.	100% of poverty Resource: \$7,390 (1), \$11,090 (2)
	SLMB	Specified Low Income Medicare Beneficiaries TennCare pays Medicare Part B premiums only.	100% to 120% of poverty Resource: \$7,390 (1), \$11,090 (2)
	QI 1	Qualified Individuals TennCare pays Medicare Part B premiums only.	120% to 135% of poverty Resource: \$7,390 (1), \$11,090 (2)
	QDWI	Qualified Disabled Working Individual TennCare pays Medicare Part A buy-in for non-aged individuals who lost SSI disability benefits and premium free Part A.	Not more than 200% of poverty Resource: \$4,000 (1), \$6,000 (2)
