

# REGISTRY OF ELECTION FINANCE

The Registry of Election Finance met Wednesday, August 21, 2013, at Suite 104 of Parkway Towers, 404 James Robertson Parkway, Nashville, Tennessee.

Presiding over the meeting was Chairperson Henry Fincher. Attending the meeting were board members Patricia Heim, Norma Lester, Darlene McNeece and Justin Pitt.

## *Approval of Meeting Minutes*

On motion by Lester, seconded by McNeece, the board voted unanimously to approve the minutes from the June 12, 2013 regular board meeting.

## *Reconsiderations*

***12-48 Washington County Republican Executive Committee***, for failure to file a 2012 pre-primary campaign financial disclosure report. Class two (2), no report filed, maximum ten thousand (\$10,000) civil penalty. The organization has had previous matters before the board. (see below)

The board voted at its October 23, 2012 meeting to issue the organization a show cause notice.

Director Rawlins informed the board that the report has been filed but that there has been no response to the show cause notice.

The board voted at its January 9, 2013 meeting to assess the organization a \$10,000 civil penalty assessment. The organization requested a reconsideration of the \$10,000 civil penalty assessment.

James Wheeler, representative for the organization, personally appeared before the board and explained the organizations failure to file the required report.

On motion by Heim, seconded by Pitt, the board voted unanimously to reconsider the \$10,000 civil penalty assessment. On motion by Heim, seconded by Pitt, the board voted unanimously to waive the \$10,000 civil penalty assessment.

***13-07 Washington County Republican Executive Committee***, for failure to file a 2012 pre-general campaign financial disclosure report. Class two (2), no report filed, maximum ten thousand (\$10,000) civil penalty. The organization has had previous matters before the board. (see above)

The board voted at its January 9, 2013 meeting to issue the organization a show cause notice.

Director Rawlins informed the board that the report has been filed but that there has been no response to the show cause notice.

The board voted at its March 13, 2013 meeting to assess the organization a \$10,000 civil penalty assessment. The organization requested a reconsideration of the \$10,000 civil penalty assessment.

James Wheeler, representative for the organization, personally appeared before the board and explained the organizations failure to file the required report.

On motion by Heim, seconded by Pitt, the board voted unanimously to reconsider the \$10,000 civil penalty assessment. On motion by Heim, seconded by Pitt, the board voted unanimously to waive the \$10,000 civil penalty assessment.

### ***Late Filing Show Cause Hearings***

***13-26 Brock Bennington***, for failure to file a 2012 4<sup>th</sup> quarter campaign financial disclosure report. Class two (2), no report filed, maximum ten thousand (\$10,000) civil penalty. Mr. Bennington has had no previous matters before the board.

The board voted at its June 12, 2013 meeting to issue Mr. Bennington a show cause notice.

Director Rawlins informed the board that there has been no response to the show cause notice and that the report still has not been filed.

On motion by Heim, seconded by McNeece, the board voted unanimously to assess Mr. Bennington a \$10,000 civil penalty.

***13-27 Brian Brewer***, for failure to file a 2012 4<sup>th</sup> quarter campaign financial disclosure report. Class two (2), no report filed, maximum ten thousand (\$10,000) civil penalty. Mr. Brewer has had no previous matters before the board.

The board voted at its June 12, 2013 meeting to issue Mr. Brewer a show cause notice.

Director Rawlins informed the board that there has been no response to the show cause notice and that the report still has not been filed.

On motion by Heim, seconded by McNeece, the board voted unanimously to assess Mr. Brewer a \$10,000 civil penalty.

***13-28 Tommie Brown***, for failure to file a 2012 4<sup>th</sup> quarter campaign financial disclosure report. Class two (2), no report filed, maximum ten thousand (\$10,000) civil penalty. Ms. Brown has had previous matters before the board.

The board voted at its June 12, 2013 meeting to issue Ms. Brown a show cause notice.

Director Rawlins informed the board that there has been no response to the show cause notice and that the report still has not been filed.

A motion was made by Heim, seconded by McNeece, to assess Ms. Brown a \$10,000 civil penalty. The motion to assess Ms. Brown a \$10,000 civil penalty failed the board 3 to 1 with Fincher voting “no” and Lester “abstaining.”

***13-29 Quenston Coleman***, for failure to file a 2012 4<sup>th</sup> quarter campaign financial disclosure report. Class two (2), no report filed, maximum ten thousand (\$10,000) civil penalty. Mr. Coleman has had previous matters before the board.

The board voted at its June 12, 2013 meeting to issue Mr. Coleman a show cause notice.

Director Rawlins informed the board that there has been no response to the show cause notice and that the report still has not been filed.

On motion by Heim, seconded by McNeece, the board voted unanimously to assess Mr. Coleman a \$10,000 civil penalty.

**13-30 Robert Dunham**, for failure to file a 2012 4<sup>th</sup> quarter campaign financial disclosure report. Class two (2), no report filed, maximum ten thousand (\$10,000) civil penalty. Mr. Dunham has had no previous matters before the board.

The board voted at its June 12, 2013 meeting to issue Mr. Dunham a show cause notice.

Director Rawlins informed the board that the report has been filed which closed his campaign account but that there has been no response to the show cause notice.

On motion by Heim, seconded by McNeece, the board voted unanimously to take no further action in this matter.

**13-31 Lewis Edwards**, for failure to file a 2012 4<sup>th</sup> quarter campaign financial disclosure report. Class two (2), no report filed, maximum ten thousand (\$10,000) civil penalty. Mr. Edwards has had a previous matter before the board.

The board voted at its June 12, 2013 meeting to issue Mr. Edwards a show cause notice.

Mr. Edwards filed the required report which closed his campaign account and submitted a sworn statement for the board's consideration.

On motion by Heim, seconded by McNeece, the board voted unanimously to take no further action in this matter.

**13-32 Anthony Hancock**, for failure to file a 2012 4<sup>th</sup> quarter campaign financial disclosure report. Class two (2), no report filed, maximum ten thousand (\$10,000) civil penalty. Mr. Hancock has had no previous matters before the board.

The board voted at its June 12, 2013 meeting to issue Mr. Hancock a show cause notice.

Mr. Hancock filed the required report which closed his campaign account and submitted a statement for the board's consideration.

On motion by Heim, seconded by McNeece, the board voted unanimously to take no further action in this matter.

**13-33 Ryan Haring**, for failure to file a 2012 4<sup>th</sup> quarter campaign financial disclosure report. Class two (2), no report filed, maximum ten thousand (\$10,000) civil penalty. Mr. Haring has had a previous matter before the board.

The board voted at its June 12, 2013 meeting to issue Mr. Haring a show cause notice.

Director Rawlins informed the board that there has been no response to the show cause notice and that the report still has not been filed.

On motion by Heim, seconded by McNeece, the board voted unanimously to assess Mr. Haring a \$10,000 civil penalty.

**13-34 Leah Kirk**, for failure to file a 2012 4<sup>th</sup> quarter campaign financial disclosure report. Class two (2), no report filed, maximum ten thousand (\$10,000) civil penalty. Ms. Kirk has had a previous matter before the board.

The board voted at its June 12, 2013 meeting to issue Ms. Kirk a show cause notice.

Director Rawlins informed the board that the report has been filed which closed her campaign account but that there has been no response to the show cause notice.

On motion by Heim, seconded by McNeece, the board voted unanimously to take no further action in this matter.

**13-35 Janis Sontany**, for failure to timely file a 2012 year-end supplemental campaign financial disclosure report. Class one (1), 28 days late, maximum seven hundred (\$700) civil penalty. Ms. Sontany has had a previous matter before the board.

The board voted at its June 12, 2013 meeting to issue Ms. Sontany a show cause notice.

Ms. Sontany submitted a statement for the board's consideration.

A motion was made by Heim, seconded by Pitt, to assess Ms. Sontany a \$100 civil penalty. A friendly amendment was made by Lester, accepted by Heim and Pitt, to assess Ms. Sontany a \$250 civil penalty. The motion to assess Ms. Sontany a \$250 civil penalty passed the board 4 to 0, with Fincher "abstaining."

**13-36 Randy Walker**, for failure to file a 2012 year-end supplemental campaign financial disclosure report. Class two (2), no report filed, maximum ten thousand (\$10,000) civil penalty. Mr. Walker has had no previous matters before the board.

The board voted at its June 12, 2013 meeting to issue Mr. Walker a show cause notice.

Mr. Walker submitted a statement for the board's consideration. Joseph D. Guess, treasurer for Mr. Walker, submitted an affidavit for the board's consideration.

On motion by Pitt, seconded by Heim, the board voted unanimously to take no further action in this matter.

**13-38 Ocoee Region Builders Association**, for failure to file a 2012 4<sup>th</sup> quarter campaign financial disclosure report. Class two (2), no report filed, maximum ten thousand (\$10,000) civil penalty. The organization has had previous matters before the board.

The board voted at its June 12, 2013 meeting to issue the organization a show cause notice.

Carol Searles, representative for the organization, filed the required report and submitted a statement for the board's consideration.

On motion by Heim, seconded by Pitt, the board voted unanimously to take no further action in this matter.

**13-37 Support Tennessee Grapes and Wines**, for failure to timely file a 2012 4<sup>th</sup> quarter campaign financial disclosure report. Class two (2), 53 days late, maximum ten thousand (\$10,000) civil penalty. The organization has had previous matters before the board.

The board voted at its June 12, 2013 meeting to issue the organization a show cause notice.

Jennifer Albrecht, treasurer for the organization, filed the required report and submitted a statement for the board's consideration.

On motion by Heim, seconded by Lester, the board voted unanimously to assess the organization a \$150 civil penalty.

**13-39 Tennessee Fire Sprinkler Contractors PAC**, for failure to timely file a 2012 4<sup>th</sup> quarter campaign financial disclosure report. Class two (2), 72 days late, maximum ten thousand (\$10,000) civil penalty. The organization has had a previous matter before the board.

The board voted at its June 12, 2013 meeting to issue the organization a show cause notice.

Director Rawlins informed the board that there has been no response to the show cause notice.

A motion was made by Heim, seconded by McNeece, to assess the organization a \$10,000 civil penalty. Heim then withdrew the motion. A motion was then made by Heim, seconded by McNeece, to assess the organization a \$150 civil penalty. The motion to assess the organization a \$150 civil penalty passed the board unanimously.

**13-40 Amy Broyles**, for failure to file a 2012 year-end supplemental campaign financial disclosure report with the Knox County Election Commission. Class two (2), no report filed, maximum ten thousand (\$10,000) civil penalty. Ms. Broyles has had previous matters before the board.

The board voted at its June 12, 2013 meeting to issue Ms. Broyles a show cause notice.

Director Rawlins informed the board that there has been no response to the show cause notice and that the report still has not been filed.

On motion by Heim, seconded by Pitt, the board voted unanimously to assess Ms. Broyles a \$10,000 civil penalty.

**13-41 Scott Davis**, for failure to file a 2012 year-end supplemental campaign financial disclosure report with the Davidson County Election Commission. Class two (2), no report filed, maximum ten thousand (\$10,000) civil penalty. Mr. Davis has had a previous matter before the board. (see below)

The board voted at its June 12, 2013 meeting to issue Mr. Davis a show cause notice.

Mr. Davis and James Weaver, representative for Mr. Davis, filed the required report with the Davidson County Election Commission and personally appeared before the board to explain Mr. Davis' failure to file the required report.

On motion by Lester, seconded by Heim, the board voted unanimously to take no further action in this matter.

**13-42 Local IAFF 4381 PAC**, for failure to timely file a 2012 year-end supplemental campaign financial disclosure report with the Maury County Election

Commission. Class one (1), 17 days late, maximum four hundred twenty-five (\$425) civil penalty. The organization has had no previous matters before the board.

The board voted at its June 12, 2013 meeting to issue the organization a show cause notice.

Director Rawlins informed the board that there has been no response to the show cause notice.

On motion by Heim, seconded by Pitt, the board voted unanimously to assess the organization a \$50 civil penalty.

### ***Cross Indexing Show Cause Hearings***

***13-45 Joe Armstrong***, for failing to report 7 PAC contributions on his 2012 campaign financial disclosure reports. Class two (2), maximum ten thousand dollar (\$10,000) civil penalty per violation. Rep. Armstrong has had previous matters before the board.

The board voted at its June 12, 2013 meeting to issue Rep. Armstrong a show cause notice.

Director Rawlins informed the board that corrections to his reports have been made but that there has been no response to the show cause notice.

On motion by Pitt, seconded by Heim, the board voted 4 to 1 to assess Rep. Armstrong a \$50 civil penalty, with Fincher voting “no.”

***13-54 Joe Carr***, for failing to report 5 PAC contributions on his 2012 campaign financial disclosure reports. Class two (2), maximum ten thousand dollar (\$10,000) civil penalty per violation. Rep. Carr has had a previous matter before the board.

The board voted at its June 12, 2013 meeting to issue Rep. Carr a show cause notice.

Rep. Carr corrected his reports and submitted a statement for the board’s consideration.

On motion by Heim, seconded by McNeece, the board voted unanimously to take no further action in this matter.

***13-53 Ben Claybaker***, for failing to report 3 PAC contributions on his 2012 campaign financial disclosure reports. Class two (2), maximum ten thousand dollar (\$10,000) civil penalty per violation. Mr. Claybaker has had a previous matter before the board. (see below)

The board voted at its June 12, 2013 meeting to issue Mr. Claybaker a show cause notice.

Mr. Claybaker corrected his reports and submitted a statement for the board’s consideration.

On motion by Pitt, seconded by McNeece, the board voted unanimously to take no further action in this matter.

***13-51 Ty Cobb***, for failing to report 3 PAC contributions on his 2012 campaign financial disclosure reports. Class two (2), maximum ten thousand dollar (\$10,000) civil penalty per violation. Mr. Cobb has had previous matters before the board.

The board voted at its June 12, 2013 meeting to issue Mr. Cobb a show cause notice.

Mr. Cobb corrected his reports and personally appeared before the board to explain his failure to report the PAC contributions.

On motion by Pitt, seconded by McNeece, the board voted unanimously to take no further action in this matter.

**13-52 John DeBerry, Jr.**, for failing to report 3 PAC contributions on his 2012 campaign financial disclosure reports. Class two (2), maximum ten thousand dollar (\$10,000) civil penalty per violation. Rep. DeBerry has had previous matters before the board.

The board voted at its June 12, 2013 meeting to issue Rep. DeBerry a show cause notice.

Rep. DeBerry corrected his reports and submitted a statement for the board's consideration.

On motion by Heim, seconded by Pitt, the board voted unanimously to take no further action in this matter.

**13-49 Barry Doss**, for failing to report 6 PAC contributions on his 2012 campaign financial disclosure reports. Class two (2), maximum ten thousand dollar (\$10,000) civil penalty per violation. Rep. Doss has had no previous matters before the board.

The board voted at its June 12, 2013 meeting to issue Rep. Doss a show cause notice.

Rep. Doss and Troy Brewer, representative for Rep. Doss, corrected his reports and personally appeared before the board to explain his failure to report the PAC contributions.

On motion by Pitt, seconded by McNeece, the board voted unanimously to take no further action in this matter.

**13-50 Mark Green**, for failing to report 3 PAC contributions on his 2012 campaign financial disclosure reports. Class two (2), maximum ten thousand dollar (\$10,000) civil penalty per violation. Sen. Green has had no previous matters before the board.

The board voted at its June 12, 2013 meeting to issue Sen. Green a show cause notice.

Sen. Green corrected his reports and submitted a statement for the board's consideration.

On motion by Pitt, seconded by McNeece, the board voted unanimously to take no further action in this matter.

**13-48 G. A. Hardaway**, for failing to report 6 PAC contributions on his 2012 campaign financial disclosure reports. Class two (2), maximum ten thousand dollar (\$10,000) civil penalty per violation. Rep. Hardaway has had previous matters before the board.

The board voted at its June 12, 2013 meeting to issue Rep. Hardaway a show cause notice.

Director Rawlins informed the board that corrections to his reports have been made but that there has been no response to the show cause notice.

On motion by Heim, seconded by McNeece, the board voted 4 to 1 to assess Rep. Hardaway a \$50 civil penalty, with Fincher voting “no.”

**13-59 Thelma Harper**, for failing to report 4 PAC contributions on her 2012 campaign financial disclosure reports. Class two (2), maximum ten thousand dollar (\$10,000) civil penalty per violation. Sen. Harper has had previous matters before the board.

The board voted at its June 12, 2013 meeting to issue Sen. Harper a show cause notice.

Sen. Harper corrected her reports and submitted a statement for the board’s consideration.

On motion by Pitt, seconded by Heim, the board voted unanimously to take no further action in this matter.

**13-47 Andrew Holt**, for failing to report 4 PAC contributions on his 2012 campaign financial disclosure reports. Class two (2), maximum ten thousand dollar (\$10,000) civil penalty per violation. Rep. Holt has had a previous matter before the board.

The board voted at its June 12, 2013 meeting to issue Rep. Holt a show cause notice.

Rep. Holt corrected his reports and personally appeared before the board to explain his failure to report the PAC contributions.

On motion by Lester, seconded by Pitt, the board voted unanimously to take no further action in this matter.

**13-46 Bill Ketron**, for failing to report 8 PAC contributions on his 2012 campaign financial disclosure reports. Class two (2), maximum ten thousand dollar (\$10,000) civil penalty per violation. Sen. Ketron has had previous matters before the board.

The board voted at its June 12, 2013 meeting to issue Sen. Ketron a show cause notice.

Sen. Ketron corrected his reports and personally appeared before the board to explain his failure to report the PAC contributions.

On motion by Pitt, seconded by McNeece, the board voted unanimously to take no further action in this matter.

**13-55 Susan Lynn**, for failing to report 4 PAC contributions on her 2012 campaign financial disclosure reports. Class two (2), maximum ten thousand dollar (\$10,000) civil penalty per violation. Rep. Lynn has had previous matters before the board.

The board voted at its June 12, 2013 meeting to issue Rep. Lynn a show cause notice.

Rep. Lynn corrected her reports and submitted a statement for the board’s consideration.

Without objection, the board voted to defer any further action in this matter until the next regularly scheduled meeting. (Lester not present at this time.)

**13-56 Debra Young Maggart**, for failing to report 4 PAC contributions on her 2012 campaign financial disclosure reports. Class two (2), maximum ten thousand dollar (\$10,000) civil penalty per violation. Ms. Maggart has had a previous matter before the board.

The board voted at its June 12, 2013 meeting to issue Ms. Maggart a show cause notice.

Ms. Maggart and Lance Wray, representative for Ms. Maggart, corrected her reports and personally appeared before the board to explain her failure to report the PAC contributions.

Without objection, the board voted to defer any further action in this matter to allow Ms. Maggart an opportunity to gather more information on the matter.

**13-58 Bo Mitchell**, for failing to report 3 PAC contributions on his 2012 campaign financial disclosure reports. Class two (2), maximum ten thousand dollar (\$10,000) civil penalty per violation. Rep. Mitchell has had previous matters before the board.

The board voted at its June 12, 2013 meeting to issue Rep. Mitchell a show cause notice.

Rep. Mitchell corrected his reports and personally appeared before the board to explain his failure to report the PAC contributions.

On motion by Pitt, seconded by Lester, the board voted unanimously to take no further action in this matter.

**13-62 Judd Matheny**, for failing to report 7 PAC contributions on his 2012 campaign financial disclosure reports. Class two (2), maximum ten thousand dollar (\$10,000) civil penalty per violation. Rep. Matheny has had previous matters before the board.

The board voted at its June 12, 2013 meeting to issue Rep. Matheny a show cause notice.

Director Rawlins informed the board that corrections to his reports have been made but that there has been no response to the show cause notice.

Without objection, the board voted to defer any further action in this matter until the next regularly scheduled meeting. (Lester not present at this time.)

**13-61 Phillip North**, for failing to report 4 PAC contributions on his 2012 campaign financial disclosure reports. Class two (2), maximum ten thousand dollar (\$10,000) civil penalty per violation. Mr. North has had no previous matters before the board.

The board voted at its June 12, 2013 meeting to issue Mr. North a show cause notice.

Mr. North corrected his reports and submitted affidavits for the board's consideration.

Without objection, the board voted to defer any further action in this matter until the next regularly scheduled meeting. (Lester not present at this time.)

**13-64 Antonio Parkinson**, for failing to report 6 PAC contributions on his 2012 campaign financial disclosure reports. Class two (2), maximum ten thousand dollar (\$10,000) civil penalty per violation. Rep. Parkinson has had no previous matters before the board.

The board voted at its June 12, 2013 meeting to issue Rep. Parkinson a show cause notice.

Rep. Parkinson corrected his reports and submitted a statement for the board's consideration.

Without objection, the board voted to defer any further action in this matter until the next regularly scheduled meeting. (Lester not present at this time.)

**13-60 Courtney Rogers**, for failing to report 7 PAC contributions on her 2012 campaign financial disclosure reports. Class two (2), maximum ten thousand dollar (\$10,000) civil penalty per violation. Rep. Rogers has had no previous matters before the board.

The board voted at its June 12, 2013 meeting to issue Rep. Rogers a show cause notice.

Rep. Rogers and Vance Dennis, representative for Rep. Rogers, corrected her reports and personally appeared before the board to explain her failure to report the PAC contributions.

On motion by Pitt, seconded by McNeece, the board voted unanimously to take no further action in this matter.

**13-57 John Tidwell**, for failing to report 3 PAC contributions on his 2012 campaign financial disclosure reports. Class two (2), maximum ten thousand dollar (\$10,000) civil penalty per violation. Rep. Tidwell has had previous matters before the board.

The board voted at its June 12, 2013 meeting to issue Rep. Tidwell a show cause notice.

Rep. Tidwell corrected his reports and personally appeared before the board to explain his failure to report the PAC contributions.

On motion by Lester, seconded by Pitt, the board voted unanimously to take no further action in this matter.

**13-63 Bill Sanderson**, for failing to report 4 PAC contributions on his 2012 campaign financial disclosure reports. Class two (2), maximum ten thousand dollar (\$10,000) civil penalty per violation. Rep. Sanderson has had a previous matter before the board.

The board voted at its June 12, 2013 meeting to issue Rep. Sanderson a show cause notice.

Rep. Sanderson corrected his reports and submitted a statement for the board's consideration.

Without objection, the board voted to defer any further action in this matter until the next regularly scheduled meeting. (Lester not present at this time.)

**13-65 Michael Sparks**, for failing to report 3 PAC contributions on his 2012 campaign financial disclosure reports. Class two (2), maximum ten thousand dollar (\$10,000) civil penalty per violation. Rep. Sparks has had a previous matter before the board. (see below)

The board voted at its June 12, 2013 meeting to issue Rep. Sparks a show cause notice.

Rep. Sparks corrected his reports and submitted a statement for the board's consideration.

Without objection, the board voted to defer any further action in this matter until the next regularly scheduled meeting. (Lester not present at this time.)

**13-66 Mike Stewart**, for failing to report 8 PAC contributions on his 2012 campaign financial disclosure reports. Class two (2), maximum ten thousand dollar (\$10,000) civil penalty per violation. Rep. Stewart has had no previous matters before the board.

The board voted at its June 12, 2013 meeting to issue Rep. Stewart a show cause notice.

Rep. Stewart corrected his reports and personally appeared before the board to explain his failure to report the PAC contributions.

On motion by Lester, seconded by Pitt, the board voted unanimously to take no further action in this matter.

**13-44 Mike Turner**, for failing to report 18 PAC contributions on his 2012 campaign financial disclosure reports. Class two (2), maximum ten thousand dollar (\$10,000) civil penalty per violation. Rep. Turner has had previous matters before the board.

The board voted at its June 12, 2013 meeting to issue Rep. Turner a show cause notice.

Rep. Turner corrected his reports and personally appeared before the board to explain his failure to report the PAC contributions.

A motion was made by Heim, seconded by McNeece, to assess Rep. Turner a \$500 civil penalty assessment. An amendment was made by Lester, seconded by Fincher, to assess Rep. Turner a \$250 civil penalty. The motion to the amendment passed the board 3 to 2, with Heim and McNeece voting "no." A motion was then made by Lester, seconded by Pitt, to assess Rep. Turner a \$250 civil penalty. The motion to assess Rep. Turner a \$250 civil penalty passed the board 4 to 1, with Fincher voting "no."

### ***Contributions Received During Session Show Cause Hearings***

**13-43 Michel Sparks**, for possible violations of the campaign contribution limits. Class two (2), maximum ten thousand (\$10,000) civil penalty. Rep. Sparks has had a previous matter before the board. (see above)

The board voted at its June 12, 2013 meeting to issue Rep. Sparks a show cause notice.

Director Rawlins informed the board that there has been no response to the show cause notice and that the corrections have not been made.

Without objection, the board voted to defer any further action in this matter until the next regularly scheduled meeting. (Lester not present at this time.)

### ***Sworn Complaints***
