

# TENNESSEE ALCOHOLIC BEVERAGE COMMISSION MINUTES

### THURSDAY, APRIL 26, 2018 11:00 a.m.

The April meeting of the Tennessee Alcoholic Beverage Commission was held on Thursday, April 26, 2018, in Nashville, Tennessee. Chairman Skiles, Commissioner Jones, and Commissioner Harb Roberts were present. In attendance on behalf of TABC staffs were the following: Director Byrd, Assistant Director Blair, CLEO Tubbs, Keith Hollingshead-Cook, Mark Reineke, Joshua Stepp, Christopher Dowell, Nancy Townsend, Nichelle Dorroh, and Coty Shadowens.

## 1. REVIEW/APPROVAL OF THE MARCH 22, 2018, COMMISSION MEETING MINUTES

**Discussion/Action Taken:** Commissioner Jones moved for approval of the minutes and Commissioner Roberts seconded the motion. The motion passed with three ayes.

Director Byrd requested that two housekeeping items be heard out of order. Director Byrd commented that the Petition for Declaratory Order was withdrawn by the Petitioner and Director Byrd commented that the applicant – Natchez Hills Vineyard requested additional time to evaluate this issue in the context of a new law.

Tavin Schram and Tad Schram are acquiring 95% ownership in the business and Teena Tipton will retain 5% interest in the LLC. The TABC staff recommends approval of this request.

**Discussion/Action Taken:** Director Byrd reviewed the matter to the Commission and recommended approval of the request. Commissioner Jones



moved for approval and the motion was seconded. The motion passed with three ayes.

Due to construction delays the applicant requested and received an initial 30 day extension by staff that extends the conditional approval through May 25, 2018. The applicant is now before the Commission to request a second extension period of thirty days. If approved, the applicant's conditional approval will be extended through June 25, 2018. The TABC staff recommends approval of this request.

**Discussion/Action Taken:** Director Byrd reviewed the matter to the Commission and recommended approval. Attorney Bill Hubbard was present on behalf of the applicant and noted the construction has been expedited. Commissioner Jones moved for approval of the extension through June 25, 2018, and the motion was seconded. The motion passed with three ayes.

Commissioner Jones moved for approval and Commissioner Roberts seconded the motion. The motion passed with three ayes. Director Byrd recommended conditional approval of the location change subject to the certificate of occupancy and TABC inspection. Commissioner Jones moved for approval and the motion was seconded. The motion passed with three ayes.

The TABC staff recommends approval of the change.

**Discussion/Action Taken:** Director Byrd reviewed the matter to the Commission and Commission Counsel, Joshua Stepp, provided clarification on the requested change. Director Byrd recommended approval of the request. Commissioner Harb Roberts moved for approval of the change and the motion was seconded. The motion passed with three ayes.

Before the Commission is a request for approval of a retail package store licensee to be located at 2716 N. John B. Dennis Hwy, Kingsport, TN 37660. Applicant is purchasing the business from the existing owner<sup>2</sup> and will lease the premises from landlord, John D. Cox. Applicant's spouse is employed by a TABC licensed wholesaler. Based on the specific facts<sup>3</sup> of this application it is the opinion of TABC staff that applicant's spouse does not have an indirect interest in the wholesaler. The TABC staff recommends conditional approval of this request subject to receipt of the following items:

### a. license fee

Discussion/Action Taken: Director Byrd reviewed the matter to the Commission and addressed the legal issue before the Commission. Director Byrd provided an overview of the issue and applicable statutes. A discussion was held. Attorney Will Cheek, the applicant, and applicant's spouse were present. In response to question from the Commission, Director Byrd recommended the applicant provide Commission with factual basis for why the license should be granted and recommended the matter be continued one month. A discussion was held and as part of the discussion, Attorney Will Cheek addressed the Commission on this matter and noted that applicant's spouse is not interested in operating the store and that her job is not related to selling alcohol to a liquor store. Mr. Cheek also noted the spouse does not receive stock options from her employment. In response to a question from the Commission Will Cheek commented he was in communication with Hank Hildebrand and that he is aware of the issue. Commissioner Roberts inquired if the spouse would be willing to sign an affidavit and Mr. Cheek indicated she would be willing to do so. Director Byrd recommended the matter be continued one month. Commissioner Roberts moved to continue the matter to May 2018 and the motion was seconded. The motion passed with three ayes. Later in the meeting, Director Byrd notified the Commission that applicant's spouse would be willing

to surrender the permit card and resign from her employment. Will Cheek requested to be heard on the matter and commented that the applicant believed the sale of the business would fall through if this matter was continued another month. The Commission discussed whether spouse's resignation from her employment would be necessary at this time. Based on comments from the Commission Director Byrd then recommended conditional approval of the application subject to receipt of an affidavit satisfactory to staff on this issues expressed by staff and the Commission and the license fee. Commissioner Jones moved for approval of the request subject to the stipulations stated by Director Byrd and the motion was seconded. The motion for conditional approval passed with three ayes.

### B. SB2518/HB15409 UPDATE and DISCUSSION

**Discussion/Action Taken:** Assistant Director Blair updated the Commission on the bill HB1540 which had been assigned Public Chapter 783. Assistant Director Blair provided an overview of each of the sections and discussed the provisions dealing with the package store moratorium and whether or not the Commission would be interested in considering whether to delegate to staff the authority to deny licenses under these circumstances. Director Byrd commented that the staff wanted to raise the issue but that a decision was not necessary at this time.

### C. RLPS UPDATE

**Discussion/Action Taken:** Director Byrd updated the Commission in this item. Director Byrd provided a breakdown on the number and type of licenses issued in RLPS.

### D. ENFORCEMENT UPDATE

**Discussion/Action Taken:** Director Byrd introduced the matter and requested CLEO Tubbs update the Commission on this item. CLEO Tubbs updated the Commission on the law enforcement actions and training within the previous month. Attorney Hollingshead-Cook updated the Commission on several significant cases from the past year including summary suspensions, license suspensions due to sales to minors, and a significant forfeiture case.
