



**TENNESSEE ALCOHOLIC BEVERAGE COMMISSION
MINUTES
TUESDAY, APRIL 25, 2017
1:30 p.m.**

The meeting was held on April 25th in Nashville, Tennessee. Although Commissioner Kaegi was not present, Acting Chairman Jones and new Commissioner Richard Skiles were in attendance and constituted a quorum. Present on behalf of staff were the following: Director Byrd, Assistant Director Blair, Commission Counsel, Joshua Stepp, and Mark Reineke.

1. INTRODUCTION OF COMMISSIONER RICHARD SKILES

Discussion/Action Taken: Acting Chairman Jones welcomed Commissioner Richard Skiles of Kenton, Tennessee, and Director Byrd spoke briefly on Commissioner Skiles' personal and professional background.

2. REVIEW/APPROVAL OF THE APRIL 6, 2017 COMMISSION MEETING MINUTES

Discussion/Action Taken: Commissioner Jones motioned for acceptance of the minutes as presented. Commissioner Skiles seconded the motion and the motion passed with two ayes.

3. RETAIL MATTERS

A. OLD BUSINESS

**1. KIMBROUGH FINE WINE & SPIRITS
MEMPHIS, TENNESSEE**

Applicant: Affluere Investments Inc.

Member(s): Doug Ketchum, 50%

Mary Ketchum, 50%

Current: Kimbrough Towers Wine and Spirits, LLC (Roy Patterson and Kathleen Z. Patterson) d/b/a Kimbrough Towers Wine and Spirits (license no. 3449)

Proposed: Affluere Investments Inc. d/b/a Kimbrough Fine Wine & Spirits

Before the Commission is a request for approval for a complete transfer of ownership of the retail package store located at 1483 Union Avenue, Memphis, TN 38104. Applicant is purchasing the business from the current owner and will lease the premises from landlord, Northland Kimbrough, LLC. The Commission continued this matter until the resolution of the declaratory judgment action filed on September 21, 2016. On April 14, 2017, the court declared the residency requirements under Tenn. Code Ann. § 57-3-204 unconstitutional and enjoined the Commission from enforcing the residency requirements. As a result, staff recommends conditional approval of this application, subject to receipt of the following:

- a. TABC inspection
- b. acknowledgment of TABC rules & regulations
- c. license fee

Discussion/Action Taken: Director Byrd reviewed the matter to the Commission and recommended conditional approval of the application, subject to receiving a TABC inspection, acknowledgment of TABC rules & regulations, and the license fee. Attorney, Kurt Winstead, addressed the Commission on behalf of the Tennessee Wine and Spirits Retailer's Association and Attorney, Keith Dennen, addressed the Commission on behalf of the applicant.

When addressing the Commission, Mr. Winstead noted that this was a "practical argument," not a legal argument. Mr. Winstead commented that the Association is appealing the ruling and asked the Commission to use its discretion to wait until the appeal had run its course before taking action. Mr. Winstead asked the Commission to use its discretion to continue to hold any out of state applications. Mr. Winstead commented that it could be in an out-of-state applicant's interest to hold off on obtaining a license in the event ruling was reversed.

Mr. Winstead commented that it was his opinion that the Commission had the discretion not to act.

Director Byrd disagreed; he commented that the Commission, per order of the Court, would be unable to consider residency, and if the basis for not-acting is on the basis of the residency issue, it was his opinion then that the failure to act would be based upon a statute that the court had enjoined the Commission from considering.

Attorney Keith Dennen addressed the Commission and noted that the Ketchum's have moved their residence to Tennessee and that the Ketchum's are prepared to move forward with obtaining the license. Mr. Dennen noted that the applicant has been waiting since June of 2016 and have a seller waiting. Mr. Dennen commented that he had advised the Ketchum's of the risk and they understand the risk.

Mr. Winstead commented that the Association was not asking the Commission to consider residency but only asking the Commission consider that the matter is still

in litigation and the practical effect of issuing a license to an out of state applicant is the ruling is reversed.

Director Byrd commented that he did not believe the Commission did have room for discretion being that the residency issue was the only impediment to licensure. Director Byrd noted that the applicant confirmed that the materials in the application were currently valid. Director Byrd recommended that the application be conditionally approved subject to the inspection, acknowledgment of rules and regulations, and the license fee.

Chairman Jones commented that he respected the opinion authority of the federal court to have taken the action that it has. Chairman Jones motioned for approval of the application, subject to receipt of inspection, acknowledgment of rules and regulations, and the license fee. Commissioner Skiles seconded the motion. The motion for conditional approval passed with two ayes. **Update: license no. 4139 issued 4/27/2017**

Licensee no. 4023, doing business at 940 Richards Road, Antioch, TN 37013, is requesting approval of a transfer of shareholder interest. Ashish Patel plans to acquire sixty-five percent of the stock of Gayatriji Inc. from existing stockholder Ragini Patel. The TABC staff recommends approval of this request.

Discussion/Action Taken: Director Byrd reviewed the matter to the Commission and recommended approval. Attorney Ginna Winfree and Mr. Ashish Patel were present. Acting Chairman Jones motioned for approval of the request and Commissioner Skiles seconded the motion; the motion for approval passed with two ayes.

premises from landlord, H&S Properties. The TABC staff recommends conditional approval of this request, subject to receipt of the following items:

- a. certificate of occupancy
- b. TABC inspection
- c. acknowledgment of rules & regulations
- d. license fee

Discussion/Action Taken: Director Byrd reviewed the matter to the Commission and recommended conditional approval subject to receipt of the certificate of occupancy, TABC inspection, acknowledgment of rules and regulations and the license fee. Acting Chairman Jones motioned for tentative approval subject to the items as stated and Commissioner Skiles seconded the motion. The motion for conditional approval passed with two ayes.

Before the Commission is a request for approval of a d/b/a name change as specified above. Applicant was conditionally approved for licensing at the January 24, 2017 meeting;¹ however, the license has yet to be issued and the applicant now wishes to use a different d/b/a name. The TABC staff recommends approval of the d/b/a name change request.

Discussion/Action Taken: Director Byrd reviewed the matter to the Commission and recommended approval. Acting Chairman Jones motioned for approval of the request and Commissioner Skiles seconded the motion. The motion for approval passed with two ayes.

Before the Commission is a request for licensing pursuant to T.C.A § 57-4-102(8)(A)⁵, of a not-for-profit private club, located at 2001 W. Elk Ave., Elizabethton, Tennessee 37643. Applicant is a nonprofit organization organized and existing under the laws of the State of Tennessee, and has approximately 200 members each paying annual dues. The TABC staff recommends conditional approval of this request, subject to the following:

- a. TABC inspection
- b. acknowledgment of rules and regulations
- c. certificate of occupancy

Discussion/Action Taken: Director Byrd reviewed the matter to the Commission and recommended conditional approval subject to receipt of the inspection, c/o, and acknowledgment of the rules & regulations. Acting Chairman Jones motioned for approval and Commissioner Skiles seconded the motion. The motion for conditional approval passed with two ayes.

9. RETAIL FOOD STORES

A. UPDATE

Discussion/Action Taken: Director Byrd updated the Commission on retail food store applications; he noted that two licenses had been issued since the last meeting, that there were fifty-two applications pending, and that applications were being supplemented with documentation.

Director Byrd commented on the renewal of retail food store licenses. Assistant Director Zack Blair addressed the Commission on the renewal process for retail food stores. Assistant Director Blair noted that staff expected to have a large volume of renewals to process at the same time and that information had been sent to the industry email list. He commented that the following would be necessary for retail food store renewal: renewal application; license fee; affidavit for food percentage requirement; verification that the store's responsible vendor status is valid on the date of renewal; verification that at least one designated manager is associated with the retail food store licensee; resolve all pending regulatory citations; submit a certificate of compliance (every two years); provide any updated documents that were submitted with the initial application, if changed.

⁵ T.C.A. 57-4-102(8)(A): "Club" means a nonprofit association organized and existing under the laws of the state of Tennessee, which has been in existence and operating as a nonprofit association for at least two (2) years prior to the application for a license hereunder, having at least one hundred (100) members regularly paying dues, organized and operated exclusively for pleasure, recreation and other nonprofit purposes, no part of the net earnings of which inures to the benefit of any shareholder or member; and owning, hiring or leasing a building or space therein for the reasonable use of its members with suitable kitchen and dining room space and equipment and maintaining and using a sufficient number of employees for cooking, preparing and serving meals for its members and guests; provided, that no member or officer, agent or employee of the club is paid, or directly or indirectly receives, in the form of salary or other compensation, any profits from the sale of spirituous liquors, wines, champagnes or malt beverages beyond the amount of such salary as may be fixed by its members at an annual meeting or by its governing body out of the general revenue of the club. For the purpose of this section, tips which are added to the bills under club regulations shall not be considered as profits hereunder. The premises, as provided in § 57-4-101(a)(2) for a club, shall also include the golf course, tennis courts and the area immediately surrounding the swimming pool, if a club offers such amenities. The alcoholic beverage commission shall have specific authority through rules and regulations to define with specificity the terms used herein and to impose additional requirements upon applicants seeking a club license not inconsistent with the definition above;

Mr. Blair noted there is an electronic link on the website and on the email sent to the email list. The link allows for retail foods store renewal documents to be uploaded to a dropbox electronically. Mr. Blair noted that Brandy Crissman is the staff point person for retail food store licenses and renewals.

Mr. Blair briefly spoke on the responsible vendor program.

B. DELEGATION OF AUTHORITY

Discussion/Action Taken: Director Byrd addressed the Commission and explained that the proposed delegation of authority would include delegating to staff the ability to continue to process retail food store applications, and in addition, to issue renewals, and other change in ownership requests.

Director Byrd suggested an extension of the delegation for an additional three months. Acting Chairman Jones commented that he was comfortable with an extension of three months, until August 31, 2017.

Chairman Jones motioned to extend the delegation until August 31, 2017. Commissioner Skiles seconded the motion. The motion to extend the delegation of authority to staff until August 31, 2017 passed with two ayes.
